

EXECUTIVE ORDER NO. 2010 - 006

RECONSTITUTING THE NAGA CITY TRICENTENARY EXECUTIVE COUNCIL AND STEERING COMMITTEES

WHEREAS, Executive Order No. 2009-003 created the Naga City Tricentenary Executive Council and Steering Committees to coordinate with the Archdiocese of Caceres in preparation for the celebration of the 300th Year of Devotion to Our Lady of Peñafrancia, Patroness of Bicolandia;

WHEREAS, considering it as an important milestone in the history of the Bicolanos' devotion to Our INA, the City Government is supporting it to guarantee a meaningful celebration;

NOW THEREFORE, by this 1st Executive Order, I, **JOHN G. BONGAT**, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order the following:
