

EXECUTIVE ORDER NO. 2010-13

RECONSTITUTING NAGA CITY LOCAL HEALTH BOARD

WHEREAS, section 102 of the Local Government Code mandates for the creation of the Local Health Board in every local government unit of the country;

WHEREAS, there is a need to reorganize the composition of the Naga City Local Health Board in order to deliver its services and to carry out all its programs and projects for the good and welfare of the constituents and strengthen the involvement and participation of the offices and agencies in the furtherance of the health and general well being of the city;
