

**EXECUTIVE ORDER NO. 2010-028****CONSTITUTING THE CITY MAYORAL AWARDS COMMITTEE 2011 AND ITS SECRETARIAT TO SELECT THE RECIPIENTS OF THE AWARDS FOR CONFERNMENT DURING THE CHARTER DAY CELEBRATION OF THE CITY OF NAGA ON JUNE 18, 2011:-**

**WHEREAS**, the search and selection of the annual City Mayoral Awards is a continuing tradition instituted by the Office of the Mayor of the City of Naga;

**WHEREA**, these Awards include

- a) Distinguished Mayoral Award;
- b) Special Mayoral Award; and
- c) Mayoral Recognition Award

**WHEREAS**, these awards are presented to individuals or groups of native Nagueños, migrant Filipinos who have resided in Naga City for at least a year; and those born in the City of Naga, though may be residing elsewhere- and have distinguished themselves by their exemplary achievements in various fields of endeavor, thereby contributing positive enhancement to Naga City's growth, honor and glory;

**WHEREAS**, conferment of these awards is one of the highlights of the annual Naga City Charter Day celebrations;

**WHEREAS**, a Naga City Mayoral Awards Committee, a Secretariat and working staff must be created to handle the activities thereto;

**NOW, THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1.** - the Naga City Mayoral Awards Committee 2011 to be composed of the following representatives from various sectors is hereby constituted, to wit:

REV. FR. REX ANDREW C. ALARCON	- Religious
MR. PHILIP T. IMPERIAL	- Business
MR. JOSE V. BARRAMEDA, JR.	- History/Culture
DR. ELNA N. CHIA	- Professionals
MRS. MELISSA SIEGLINDE B. BULAONG	- Government
MR. AL UBAÑA	- Media
MR. JOSE ANTONIO A. AMPARADO	- Private Sector

**SECTION 2. - Functions of the Mayoral Awards Committee**

- 1) To review the criteria and guidelines of the selection process;
- 2) To search, validate, review, evaluate and select the 2011 Mayoral Awardees following the established Guidelines, Rules and Criteria of the awards;
- 3) To submit to the City Mayor, on or before May 31, 2011, the names of the Mayoral Awardees for approval and conferment during the Charter Day Celebration of the City of Naga on June 18, 2011;
- 4) The Mayoral Awards Committee members shall elect from among themselves their chairman. and other positions as may be deemed necessary by the Committee.

**SECTION 3. - The Secretariat** who shall provide the secretarial functions of the Mayoral Awards Committee is hereby constituted to be composed of the following:

with selected staff

**SECTION 4. - Functions of the 2011 Secretariat:**

- 1) To provide the Mayoral Awards Committee with the various forms, guidelines and criteria of the awards;
- 2) To assist in the search, accept, pre-screen according to criteria and basic qualifications all nominations to the 2011 Mayoral Awards;
- 3) To submit to the Mayoral Awards Committee on or before May 20, 2011 the pre-qualified nomination documents for final validation, evaluation, and selection.

**SECTION 5. Project Coordinator** - A Project Coordinator is hereby named to assist the Mayoral Awards Committee, the Secretariat, and other concerned bodies in the coordination and execution of the various activities of the Awards so as to come up with a prestigious 2011 Mayoral Awards Presentation, to wit:

MR. JOSE B. PEREZ, External Relations and City Publication Officer  
He shall be assisted by his staff.
