

EXECUTIVE ORDER NO. 2011-001

**CREATING THE NAGA CITY ARTS MONTH CELEBRATION EXECUTIVE COMMITTEE
AND DEFINING ITS FUNCTIONS AND RESPONSIBILITIES:-**

WHEREAS, recognizing the importance of culture and the arts in raising pride in our identity and promoting national unity, the City Government joins the call of the National Government through Memorandum Circular no. 2009 -004 issued by the Department of Interior and Local Government in undertaking activities that will enhance our citizens' understanding and appreciation of arts and culture;

WHEREAS, the City of Naga will celebrate this February the "Philippine International Arts Month" pursuant to Presidential Decree No. 683 dated January 28, 1991;

WHEREAS, the City of Naga, as an LGU, in its celebration, is given the leeway to choose its sub-theme that is most relevant to its local condition and community aspirations depending on the focus and direction of activities promoting arts and culture;

WHEREAS, there is a need to create a Committee that will guarantee its meaningful celebration, ensure proper coordination, and the over-all success in the conduct of activities;

NOW THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. The Naga City Arts Month Celebration Executive and Steering Committees are hereby created with the following composition:
