

EXECUTIVE ORDER NO. 2011 - 008

**CONSTITUTING THE "ALDAW KAN MAOGMANG NAGA"
EXECUTIVE COUNCIL AND STEERING COMMITTEES IN
LINE WITH THE CITY'S 63RD CHARTER DAY CELEBRATION:-**

WHEREAS, by virtue of Republic Act No. 305 enacted on June 18, 1948, the City of Naga was established under the provisions thereof;

WHEREAS, in order to commemorate the charter anniversary of the City of Naga, June 18 of each year was declared as Naga City Charter Day and a special nonworking holiday by virtue of Republic Act No. 9210;

WHEREAS, in order to enable the City Government of Naga to effectively carry out and implement these activities, there is a need to constitute, organize, and create a "Maogmang Naga" Festival Executive and Steering Committees in line with the *63rd Naga City Charter Anniversary* to include local government departments and offices, private sector organizations and individuals, non-government institutions, and socio-civic groups;

NOW THEREFORE, I, **JOHN G. BONGAT**, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1.Maogmang Naga Festival Executive and Steering Committees are hereby created with the following composition:

SECTION 2. Functions. The Committee shall perform the following functions:

- a. To plan and ensure the smooth coordination of programs, events and activities in connection with the celebration of the *63rd Naga City Charter Anniversary*;
- b. To find ways and means to support the effective implementation of programs, events and activities during the celebration; and
- c. Perform such other acts which are necessary to effectively and meaningfully carry out their mandated functions.

SECTION 3. Secretariat. There shall be a Secretariat headed by the Acting City Administrator which shall provide secretariat support to the Execom and coordinate the efficient implementation of all the Execom's policies and directives.

SECTION 4. Celebration Theme. The Execom shall plan all events and activities around the theme: *"Maogmang Naga sa Bagong Dekada"* which in essence shall affirm Naga's rich history and culture and Nagueños indomitable spirit and character.

SECTION 5. Funding. Funding for the celebration, operating requirements and honoraria and such other expenses to be incurred in connection with the celebration of the *"Maogmang Naga Festival"* shall be sourced mainly from the budget provided by the City Government for this purpose and may be augmented by private sector sponsorships. All other departments and offices are authorized to allocate such amounts as may be necessary to defray expenses of this celebration subject to the usual government accounting and auditing rules and regulations.

SECTION 6. Effectivity. This order shall take effect immediately.
