

EXECUTIVE ORDER NO. 2011 - 009

**CONSTITUTING A TECHNICAL WORKING GROUP (TWG) TO STUDY THE FEASIBILITY OF THE ESTABLISHMENT OF A CENTRAL TRUCK AND CONTAINER VAN TERMINAL IN NAGA CITY:**

**WHEREAS**, Naga City is regarded as the regional center of trade and commerce, as shown by the big number of trucks, container vans and the like delivering goods, products, supplies and materials to all business establishments within the city;

**WHEREAS**, in previous studies conducted, one of the major causes of traffic congestion in city streets and thoroughfares is the presence of trucks and container vans whose enormous size and difficulty in maneuvering is without doubt one of the reasons therefor on a daily basis;

**WHEREAS**, due to the influx of new businesses and enterprises in the city and as supply and demand dictates, it is certain that more trucks and/or container vans will come in to Naga;

**WHEREAS**, the new leadership has envisioned the establishment of a central truck and container van terminal that will serve as holding area of the same and for the purpose of decongesting street shoulders and traffic in city roads and streets;

**WHEREAS**, not only will the terminal solve some of our heavy traffic congestion the same will usher in new investments and create new jobs within the city, further spurring commercial growth and economic development;

**WHEREAS**, it is necessary to constitute a technical working group to study the feasibility of having a central truck and container terminal in Naga City;

**NOW THEREFORE, I, JOHN G. BONGAT**, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1.** The TWG that shall conduct a study on the feasibility of the establishment of a central truck and container van terminal in Naga City, shall be composed of the following:

Ms. Helen T. Rosales, City Treasurer

Within thirty (30) days from issuance of this executive order, the TWG shall submit to the City Mayor a copy of its report and recommendations.

The TWG may call upon the aid of any department of the City Government and/or agencies of the national government in the conduct of its study. The City Planning and Development Office shall serve as Secretariat of the TWG herein constituted.

Section 2. This Executive Order shall be effective immediately.
