

EXECUTIVE ORDER NO. 2011- 017

CREATING THE NAGA CITY PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL

WHEREAS, Article XIV, Section 19 (1), of the Constitution provides that “The state shall promote physical education and encourage sports program, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, the City of Naga is mandated under Republic Act No. 7160 to conduct and coordinate sports activities in its jurisdiction;

WHEREAS, there is a need to establish a Naga City Physical Fitness and Sports Development Council pursuant to Executive Order no. 63 issued March 1, 1993 by then President Fidel V. Ramos;

WHEREAS, the Council herein created seeks to generate interest in and awareness of the benefits of regular physical activity and active sports participation; stimulate and enhance coordination of programs within and among the private and public sectors that promote participation in, and safe and easy access to, physical activity and sports; expand availability of quality information and guidance regarding physical activity and sports participation; integrate physical activity into a broader health promotion and disease prevention effort through public agencies and the private sector; and target all Nagueños with particular emphasis on children and adolescents, as well as populations or communities in which specific risks or disparities in participation in, access to, or knowledge about the benefits of physical activity have been identified;

NOW THEREFORE, WE, JOHN G. BONGAT, Mayor of Naga City and **JENNY B. ORPIA**, City Youth Mayor, by virtue of the powers vested in us by law, do hereby order the following:

Section 1. There is hereby constituted the Naga City Physical Fitness and Sports Development Council which shall act as the citywide organizational network to assist in the planning, information dissemination, and actual implementation and monitoring of policies and programs on Sports Development and shall be composed of the following:

Section. 2. Functions. –The Council shall assume the following functions and responsibilities:

1. Meet at least once a month to plan and formulate a blueprint for the short, medium, and long term programs for the sectoral sports;

2. Plan and develop a sustainable program for the maximum utilization of the Metro Naga Sports Complex including the establishment of a Sports, Recreation and Amusement Park within the complex on a possible Build-Operate-Transfer (BOT) or other feasible scheme;
3. Conduct local "Sports Summits" in consultation with sports associations and other public and private entities concerned to identify and prioritize sports programs and activities in their respective localities and areas of concern and to monitor, review and validate their programs;
4. Oversee and ensure the implementation of the physical fitness and sports programs and activities;
5. Disseminate proper information on the national policy and program, including their local programs to encourage the active participation of their constituents in physical fitness and sports activities;
6. Assist in the identification, recruitment, and training of gifted and talented athletes from their areas to ensure a wide base for the selection of national athletes who will represent the country in international sports competitions; and,
7. Perform other functions deemed necessary to promote and implement sports plans, programs and activities, as maybe suggested by the City Mayor.

Section 3. All heads of departments and offices, are hereby directed to support the program and activities of the Physical Fitness and Sports Development Council.

Non-governmental Organizations, and the various Local Sports Associations, are hereby requested to lend their full cooperation and active participation in ensuring that priority is given to physical fitness and sports to foster camaraderie and unity, patriotism and nationalism, accelerate social progress, preserve human resources, and promote total human liberation and development.

Section 4. This Executive Order shall be effective immediately.
