

EXECUTIVE ORDER NO. 2011-019

CREATING THE BARLIN STREET IMPROVEMENT TASK FORCE

WHEREAS, Section 14 of Article XIV of the 1987 Philippine Constitution declares that the State “shall foster the preservation, enrichment and dynamic evolution of the Filipino culture based on the principle of unity in a climate of free artistic and intellectual expression”;

WHEREAS, Barlin Street in Barangay Sta. Cruz, Naga City is named after the first Filipino Bishop, Most Rev. Jorge Barlin, D.D., a Bikolano, who served as Bishop of Caceres from 1906 -1909 and in commemoration of his invaluable contribution to Bicol and Philippine History; giving pride to Ciudad de Nueva Caceres, now the City of Naga;

WHEREAS, to perpetuate Bishop Barlin’s role in Bicol and Philippine history, the City Government of Naga seeks conserve Barlin Street to enhance promotion of Naga’s cultural heritage;

NOW THEREFORE, WE, JOHN G. BONGAT, Mayor of Naga City and **JENNY B. ORPIA**, City Youth Mayor, by virtue of the powers vested in us by law, do hereby order the following:

Section 1. Task Force Composition - A special taskforce to be called as Barlin Street Beautification and Improvement Task Force, BSITF for brevity is hereby being created to be composed of the following:

Chairperson: Msgr. Zosimo Ma. Sañado, H.P.,
 Parish Priest, St. John the Evangelist Parish
 Naga Metropolitan Cathedral

The task force shall have as member representatives from the City Engineer’s Office (CEO), the City Properties Management Office (CPMO), the City Solid Waste Management Office (CSWMO), United Architects of the Philippines (UAP), the Punong Barangay of Sta. Cruz, and two (2) representatives from the private sector to be appointed by the Chairman.

Section 2. Functions of the Task Force - The BSITF shall have the following duties and responsibilities :

- a) Prepare the project paper which includes but is not limited to the budget, timeframe, committees, and manner of implementation of the proposed

- improvements to Barlin St. The project paper shall be submitted to the City Mayor for approval;
- b) Oversee the progress and facilitate the development of the project, provided that it shall report regularly to the City Mayor;
 - c) Solicit funds from private individuals, groups and/or organizations for the implementation of plans and projects;
 - d) The Chairman is hereby directed to make a research of the history and cultural importance of Barlin Street to set the direction of the project;
 - e) CEO is directed to initiate the preliminary site inspection and prepare the conceptual design for Barlin Street. The same office is also instructed to prepare the plans and program of work specifics in accordance with the concept for the project based on the historical research;
 - f) The CPMO, pursuant to its functions under Executive Order 2010-07, is directed to monitor the proper care and maintenance of Barlin Street in accordance with the plans and specifications;

SECTION 5. Effectivity. This order shall take effect immediately.
