EXECUTIVE ORDER 2013-035

**AMENDING EXECUTIVE ORDER NO. 2010-027, OTHERWISE KNOWN AS
"RECONSTITUTING THE NAGA CITY INVESTMENT BOARD"**

WHEREAS, Ordinance No. 97-114, or the "Naga City Investment Incentives Code of 1997," created the Naga City Investment Board (NCIB) whose main functions are to:

- Recommend policies to strengthen the city's attractiveness to investors;
- Review and adopt Naga's Investment Promotions Program;
- Periodically review the list of priority investment areas and activities; and
- Register, approve or disapprove the application for incentives of new and existing investors;

WHEREAS, the term of office of the members of the NCIB, under Section 30 of the same Code, is co-terminus with the term of office of local officials;

WHEREAS, Section 29 of the Code defines the composition of the NCIB and states that:

The Board shall be composed of the City Mayor and ten members appointed by the city mayor of which five shall come from the government and five from the private sector. Three of the appointees from the private sector shall come from among the nominees of the business community in the city while two shall come from the developmental non-government organizations as nominated by the Naga City People's Council. The city mayor shall be the chairman while the vice-chairman shall be appointed by the city mayor from among the private sector representatives. The Executive Director of the IPAC shall sit as ex-officio member.

NOW, THEREFORE, I JOHN G. BONGAT, Mayor of Naga City, do hereby reconstitute the Naga City Investment Board with the following composition:

Chairperson - HON. JOHN G. BONGAT, City Mayor
Vice Chairperson- to be elected by the members from the private sector for subsequent confirmation by the City Mayor
