EXECUTIVE ORDER NO. 2014-013

IMPLEMENTING THE "SPORTS FOR EDUCATION OF OUT-OF-SCHOOL LEARNERS PROJECT (SEOLP)" AND STRENGTHENING THE SUPPORT TO THE BASIC EDUCATION PROGRAM AND THE IMPLEMENTATION OF THE ALTERNATIVE LEARNING SYSTEM (ALS) OF THE DEPARTMENT OF EDUCATION (DepEd) BY REQUIRING ALL OUT-OF-SCHOOL CHILDREN, YOUTH, AND ADULTS (OSCYAs) TO ENROL IN THE BASIC OR FORMAL EDUCATION SYSTEM, AND, IF ALREADY QUALIFIED, ENROLL IN THE ALTERNATIVE LEARNING SYSTEM (ALS) AND ATTEND REGULAR CLASSES IN THE ESKWELA OR COMMUNITY LEARNING CENTER BEFORE ALLOWING THEM TO PARTICIPATE OR PLAY IN SPORTS TOURNAMENTS ORGANIZED & SPONSORED BY THE BARANGAY AND THOSE ORGANIZED AND SANCTIONED BY THE NAGA CITY GOVERNMENT, AND FOR OTHER PURPOSES:

WHEREAS, it is the City's declared policy to protect and promote the right of its constituents to quality education at all levels and recognize education as a priority program;

WHEREAS, basic education is intended to meet basic learning needs which provides the foundation on which subsequent learning can be based. It encompasses kindergarten, elementary and secondary education as well as alternative learning systems for out-of-school learners and those with special needs;

WHEREAS, Alternative Learning System (ALS) is an alternative way of acquiring basic education for elementary and secondary comparable with formal education. In support to the goals of Education for All (EFA 2015), it has made great stride in the delivery of its basic education and literacy development services for out-of-school youth, children, and adults. Its mission is to provide learning opportunities that will empower them to continue learning in any manner, at any time and any place they want to achieve their goals of improving quality of life and becoming more effective contributors to society;

WHEREAS, strengthening the support to the Basic Education Program and the implementation of the Alternative Learning System (ALS) of the Department of Education (DepEd) by requiring that all out-of-school children, youth, and adults (OSCYAs) particularly the school drop-outs to enroll in the formal education system, and if already qualified, enroll in the Alternative Learning System (ALS) and attend regular classes in the eskwela or community learning center where they are enrolled before allowing them to participate or play in barangay organized or sponsored sports competitions and those sanctioned by the Naga City Government will further address the learning needs of all elementary and secondary school drop-outs;

SECTION 1. LEGAL BASIS. The legal basis for the issuance of this Executive Order is Section 2 of Republic Act No. 9155, reproduced hereunder, to wit:

"Sec. 2. Declaration of Policy. - It is hereby declared the policy of the State to protect and promote the right of all citizens to quality basic education and to make such education accessible to all by providing all Filipino children a free and compulsory education in the elementary levels and free education in the high school level. Such education shall also include alternative learning systems for out-of-school youth and adult learners. - x x x -

The State shall encourage local initiatives for improving the quality of basic education. The State shall ensure that the values, needs and aspirations of a school community are reflected in the program of education for the children, out-of-school youth and adult learners. Schools and learning centers shall be empowered to make decisions on what is best for the learners they serve."

SECTION 2. TITLE and OBJECTIVES. This Order for brevity shall be known as the "Sports for Education of Out-of-School Learners Project (SEOLP)" and it aims to achieve the following objectives; to wit:

- 1) To help all out-of-school children, youth, and adults particularly those school drop-outs of the city to finish their elementary and secondary education by requiring them as a pre-requisite to participation in sports competitions organized and sanctioned by the barangay and the city government to enroll and avail of the services of the DepEd's formal or basic education system and its Alternative Learning System;
- 2) Continuously and effectively provide free basic education and literacy development services to all target beneficiaries by strengthening the sports programs and providing mechanism for participation in all sports competitions of OSCYAs;
- 3) Encourage all Barangay Councils to strengthen its sports program and ensure maximum participation in all sports competitions and tournaments organized, sponsored, and sanctioned by the barangays and the city government of all OSCYAs who are enrolled in the Alternative Learning System (ALS);
- 4) Sustain the programs and services provided by DepEd and its ALS by requiring all OSCYAs in all barangays to enroll in formal education or, if already qualified, in ALS; and
- 5) To totally address illiteracy in the City of Naga.

SECTION 3. IMPLEMENTING MECHANISM. The "Sports for Education of Out-of-School Learners Project (SEOLP)" shall follow the following implementing mechanism; to wit:

- 1) All participants in the Inter-Barangay competitions and other sports tournament organized, sponsored, and sanctioned by the city this year, and the year thereafter, are required to submit original or certified true copy of Matriculation Form or Certificate

of Enrolment as one of the major requirements in addition to what are required by the SP Committee on Sports and Youth Development and the Naga City Sports Office.

- 2) All out-of-school children, youth, and adults (OSCYAs) particularly the school drop-outs participating in the inter-barangay competition and other sports tournament organized, sponsored, and sanctioned by the city starting CY 2014 and the year thereafter are required to enroll in Basic Education Program, and, if qualified, in the Alternative Learning System (ALS) of the Department of Education (DepEd).
- 3) Out-of-school children, youth, and adults (OSCYAs) particularly those who are school drop-outs are required to enroll in formal education, and, if qualified, to the Alternative Learning System before permitting them to participate in the inter-zone or inter-color tournaments and other sports events organized or sponsored by the barangay.
- 4) Identified out-of-school children, youth, and adult shall be allowed only to participate and compete in the sports events organized and sponsored by the barangay and in the Inter-Barangay tournament upon submission of the following; (a) Certificate of Enrolment duly signed by the Barangay Literacy Worker, the ALS Coordinator or Instructional Manager, and the Education Program Supervisor of ALS - Naga City Division and (2) Commitment Form that they will finish their course in ALS and take and pass the Accreditation & Equivalency Test;
- 5) Requirements #1 to #4 shall apply to the participation of all players in all sports events and tournaments that will be organized, sponsored, and sanctioned by the 27 barangays and the Naga City Government thru the SP Committee on Sports and Youth Development and the Naga City Sports Office.

SECTION 4. DUTIES & RESPONSIBILITIES OF DEPED-ALS, LGU-NAGA, AND THE BARANGAY COUNCIL. It is the duties and responsibilities of the DepEd-ALS, LGU-Naga, and the Barangay Council to:

- 1) Intensify the campaign for "Sports for Education of Out-of-School Learners Project (SEOLP)" using all means available that would include the participation and support of the print and broadcast media;
- 2) Consolidate data pertaining to household surveys conducted by Barangay Literacy Worker (BLW) in every barangay showing the result on the number of out-of-school children, youth, and adults (OSCYAs) that will be used as basis for the effective implementation of "Sports for Education of Out-of-School Learners Project (SEOLP)";
- 3) DepEd ALS shall ensure the issuance in each enrolled out-of-school children, youth, and adult of valid Certification of Enrolment and Commitment Form which will serve as his/her permit to play in the Inter-Barangay competition and other sports tournament organized, sponsored, and sanctioned by the city;
- 4) Monitor and assist enrolled OSCYAs in ALS until they satisfactorily meet all the requirements needed to take and pass the Accreditation and Equivalency (A&E) Test; and
- 5) Implement other measures approved by all parties concerned ensuring the strict and effective compliance of this Order.

SECTION 5. FUND ALLOCATION. The amount necessary to complete or accomplish the objectives of this Order is hereby set aside chargeable against the Special Education Fund (SEF) of the city.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
