**EXECUTIVE ORDER NO. 2014-018**

**REQUIRING THE CITY CIVIL REGISTRY TO TRANSMIT ON A MONTHLY BASIS THE LIST OF MARRIAGES CONTRACTED IN THE CITY OF NAGA TO THE BARANGAY/S OF THE CONTRACTING PARTIES' RESIDENCE, THRU THE CITY POPULATION AND NUTRITION OFFICE (CPNO), FOR POSSIBLE INCLUSION OF WOULD-BE MOTHERS IN THE EARLY NUTRITION INTERVENTION PROGRAM OF THE CITY GOVERNMENT:**

**WHEREAS**, the existing nutrition intervention program of the city government starts with detected pregnant mothers;

**WHEREAS**, trainings and seminars that enhance parents' knowledge and capabilities in ensuring the health and nutrition of mothers and their would-be babies are in place;

**WHEREAS**, it is essential for married couples to attend the aforementioned trainings and seminars;

**WHEREAS**, married couples must be informed of details regarding scheduled trainings and seminars so that they may be guided and oriented properly by Barangay Nutrition Scholars on pre-natal health care practices;

**WHEREAS**, the city government wants to ensure that the nutrition intervention program be more proactive and anticipative, and an earlier intervention to achieve this end is for the Barangay Nutrition Scholars to include newly weds as clients as nearest as possible to the date of their marriage;

**WHEREAS**, in order to update the records of the Barangay Governments in the City of Naga and for the purpose of easy relaying of information to married couples in every barangay, an appropriate system of data banking must be implemented;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. Transmittal of List of Marriages Contracted.** The City Civil Registry shall, on a monthly basis, transmit the list of marriages contracted in the City of Naga every month to the different barangays, where one or both of the parties come from or reside/s, as appearing in the Marriage Contract/Certificate, thru the CPNO.

**Section 2. Responsibility of CPNO and the BNS.** The CPNO shall direct the Barangay Nutrition Scholars of every Barangay in the City of Naga to locate the residence of newly married couples based on information from their marriage contracts/certificates, and include them in parenting seminars or any other activities and interventions which may enhance the

couples' knowledge and capabilities in ensuring the health and nutrition of mothers before, during, and after pregnancy, as well as of the babies in their womb and after delivery.

**Section 3. Reportorial Requirements.** Barangay Nutrition Scholars shall be required to include in their report submitted regularly to the CPNO the list of newly weds in their respective barangays and the intervention/s made, if any.
