EXECUTIVE ORDER NO. 2014-029

CONSTITUTING THE ANDUYOG FUND MANAGEMENT TEAM:

WHEREAS, the City of Naga is now known all over the country and even abroad as a center for transparency, innovation and good governance;

WHEREAS, the many recognitions and awards that have been conferred to the city for its various development initiatives and programs, coming from prestigious national and international award-giving bodies, attest to the kind of governance that has been pursued in the City of Naga for almost two decades now;

WHEREAS, in order to address the challenge of continuously improving existing initiatives and formulating new ones relative to excellent governance in the city, Ordinance No. 2008-054, otherwise known as "AN ORDINANCE CREATING A TRUST FUND ACCOUNT CALLED ANDUYOG FUND, DEFINING ITS PURPOSE AND PRESCRIBING GUIDELINES FOR COLLECTION AND DISBURSEMENT", was ordained on August 5, 2008;

WHEREAS, the aforementioned ordinance seeks to generate funds for the city government from well-meaning people or from donors or sponsors who are willing to finance certain components of priority development programs or projects of the city;

WHEREAS, the aforementioned ordinance states that any person or entity may donate cash and contribute to the city's "Anduyog Fund", whether such person or entity is a Nagueño or not, Filipino or foreigner, living in the city or not, residing in the Philippines or abroad;

WHEREAS, pursuant to Ordinance 2008-054, the creation of a specific group or team is essential for the effective and efficient management of the trust fund;

NOW, THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the power and authority vested in me by law, do hereby order the following:

Section 1. Creation and Purposes. For purposes of effectively and efficiently managing the city's "Anduyog Fund" and to facilitate cash donations exclusively for the same, a Management Team is hereby constituted.

Section 2. Composition. The Management Team shall be comprised of the following:

Chairman: City Mayor

Members: Two (2) members of the Sangguniang Panlungsod (SP)
Committee on Ways and Means
City Planning and Development Officer
One (1) representative from the Metro Naga Chamber of
Commerce and Industry (MNCCI)
One (1) representative from the Filipino-Chinese Chamber of
Commerce (PCCCI)
One (1) representative from the Camarines Sur Bankers
Association (CSBA)
Executive Director of the Naga City Peoples Council (NCPC)

The members may designate an Executive Officer from among themselves.

Section 3. Duties and Responsibilities.

The Team shall have the following duties and responsibilities:

- Manage the city's "Anduyog Fund", in consultation with the Sangguniang Panlungsod;
- Make implementing rules for specific provisions of Ordinance 2008-054;
- Properly introduce and promote the Anduyog Fund for the general public's information and engagement thru its formal launching, the cost of which may be charged against whatever appropriate fund is available in the 2014 Annual Budget at the discretion of the City Mayor.

Section 4. Effectivity Clause. This order shall take effect immediately and shall remain in full force and effect unless amended or revoked.
