**EXECUTIVE ORDER NO. 2015-008**

**APPOINTING MR. KENJIE E. JIMENEA AND MR. JOSE B. PEREZ AS REPRESENTATIVES OF THE ACADEME AND THE PRIVATE SECTOR, RESPECTIVELY, IN THE OUTSTANDING SANGGUNIANG BARANGAY AWARDS COMMITTEE AND DIRECTING THE SAID AWARDS COMMITTEE TO COMMENCE PERFORMANCE OF THEIR FUNCTIONS:-**

WHEREAS, the Sangguniang Panlungsod of Naga enacted Ordinance No. 2014-008, otherwise known as the ENABL<sup>2</sup>E Ordinance of Naga City, which institutionalizes the Empowerment aNd Advancement of Barangays on Local LEGislation (ENABL<sup>2</sup>E) Program and seeks to promote good governance practices at the 27 barangays of Naga through institutionalizing;

WHEREAS, the ENABL<sup>2</sup>E Program, which generally aims to capacitate the newly-elected officials of the 27 barangay of Naga City to better participate in legislative sessions, craft responsive legislation and rational regulatory policies, and to become advocates of good governance, has four components, among them the Outstanding Sangguniang Barangay Award;

WHEREAS, the Outstanding Sangguniang Barangay Award, as a monitoring and evaluation mechanism of the ENABL<sup>2</sup>E Program, shall recognize barangay councils which have demonstrated exemplary performance in enacting legislative measures that greatly contribute to the achievement of sustainable and inclusive socio-economic development in their respective communities;

WHEREAS, in order to efficiently and effectively implement the Outstanding Sangguniang Barangay Award, the Outstanding Sangguniang Barangay Awards Committee is constituted;

WHEREAS, the Outstanding Sangguniang Barangay Awards Committee is comprised of the Secretary to the Sangguniang Panlungsod, Director of Department of the Interior and Local Government-Naga City, Director of the Jesse M. Robredo Governance Institute, as well as a representative from the academe and a representative from the private sector, who, pursuant to Ordinance No. 2014-008, should be appointed by the city mayor;

NOW, THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order:

**Section 1. Appointment.** Pursuant to the provisions of Ordinance No. 2014-008, otherwise known as the ENABL<sup>2</sup>E Ordinance of Naga City, Mr. Kenjie E. Jimenea of University of Nueva Caceres and Mr. Jose B. Perez of Metro Naga Chamber of Commerce and Industry are hereby appointed as representatives from the academe and the private sector, respectively, in the Outstanding Sangguniang Barangay Awards Committee.

**Section 2. Conduct of Functions and Responsibilities.** In view of the appointment made above, the Outstanding Sangguniang Barangay Awards Committee is now fully constituted and is hereby directed to commence performing their duties provided under Ordinance No. 2014-008, to wit:

- i. Craft and implement guidelines on the efficient implementation of the Outstanding Sangguniang Barangay Award;
- ii. Review and suggest amendments, if necessary, in the criteria provided in Ordinance No. 2014-008;
- iii. Conduct random visitation and observation of the deliberations (sessions or committee hearings or both) being conducted by the 27 barangay councils of Naga;
- iv. Review, validate, evaluate and select the Outstanding Sangguniang Barangay Awardees following the criteria established in Ordinance No. 2014-008 and guidelines set by the committee;
- v. Submit to the Vice Mayor and the members of the Sangguniang Panlungsod not later than one and a half (1 ½ ) years, or eighteen months, after the last day of implementation of the SP Watch and SP Forum, the list of the Outstanding Sangguniang Barangay Awardees for approval and conferment; and,
- vi. Plan and conduct a prestigious Outstanding Sangguniang Barangay Awards Presentation.

**Section 3. Timeline.** The Outstanding Sangguniang Barangay Awards Committee is provided until October 31, 2015 to perform the duties outlined above and to submit to the Sangguniang Panlungsod, headed by Vice Mayor Nelson S. Legacion, of the list of the Outstanding Sangguniang Barangay Awardees.


**Section 4. Effectivity.** This order shall take effect immediately.
