EXECUTIVE ORDER NO. 2016-004

**RECONSTITUTING THE LOCAL GOVERNANCE
PERFORMANCE MANAGEMENT SYSTEM (LGPMS) TEAM:**

WHEREAS, the Department of the Interior and Local Government (DILG) developed the Local Governance Performance Management System (LGPMS), a web-based system that has the ability to produce information on the state of local governance performance, and the state of local development, using governance and development indicators;

WHEREAS, the LGPMS, for brevity, serves as a robust on-line national information system on local governments; and is a self-assessment, management and development tool that enable local governments to determine their capabilities and limitations in the delivery of essential public services;

WHEREAS, there is a need to reconstitute the Naga City LGPMS Team in order to ensure that a member(s) of the team who has transferred, promoted, resigned or been terminated be properly replaced;

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the power vested in me by law do hereby order:

Section 1. Directive. In order to address the aforementioned points, the Local Governance Performance Management System (LGPMS) Team is hereby reconstituted.

Section 2. Composition. The LGPMS Team shall be composed of the following:

Section 3. Functions. The LGPMS Team shall coordinate closely with the DILG Officer and shall provide appropriate information and confirm/certify data for the LGPMS-LGU Profile. Further, they shall ensure that the LGPMS serves as the operational tool for the Seal of Good Local Governance (SGLG) assessment at the local level.

Section 4. Effectivity - This Executive Order shall take effect immediately.
