EXECUTIVE ORDER NO. 2016-006

**CREATING THE NAGA CITY URBAN POOR APPLICATION
VERIFICATION AND EVALUATION TASK FORCE TASKED TO VERIFY
& EVALUATE PENDING HOMELOT APPLICATIONS:**

WHEREAS, the passage of **City Ordinance 98-033**, known as the *Kaantabay Sa Kauswagan* Program on March 13, 1998 established a foundation for a comprehensive and continuing development program for the urban poor sector in Naga City;

WHEREAS, from the start of the program until today, the continuous flow of homelot applications has resulted in increase in the number of waitlisted applications for resettlement homelot filed with the Housing & Settlements Development Office (HSDO), now reaching more than 6,000;

WHEREAS, in order for the city government of Naga to have a comprehensive list of home lot applicants, only those who are still considered active shall be retained in the master list of priority applicants. They shall be counted as potential home lot beneficiaries in the proposed one time-big time, well-planned, self-contained, and livable community for informal settlers and urban poor families of the city. There is a need for this review and validation work to be effected at once. The provisions of Article V, Section 15 of the above-quoted Ordinance regarding the order of prioritization of beneficiaries shall strictly be followed;

NOW THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order the creation of the Naga City Review and Validation Task Force to be composed of the following, to wit:

Section 1. Composition. The Naga City Urban Poor Application Verification & Evaluation Task Force is hereby organized, to be composed of the following:

Members: Mr. Cesar Magistrado-Assistant City Assessor
Mr. Eric Salvino- Ginhawang Nagueño Executive Manager

Kagawad in-Charge of the Urban Poor Affairs Committee or its equivalent at the Barangay where the applicants reside, one each from the twenty-seven (27) barangays of the city

Section 2. Period of Review and Validation. The Task force shall be given 60 calendar days to make the necessary review and validation work of the applicants' application documents and existence. At the end of the period, the Task Force shall submit to the Chief Executive a report containing the information regarding their work.

Section 3. Schedule of Meeting and Funding. The Task Force members shall have a regular meeting once a week and shall agree on the day and venue of the meeting to discuss the progress of their work. Funding for this project shall be sourced from the existing budget of the HSDO and the Urban Poor Trust Fund, subject to the usual auditing rules and regulations.

Section 4. This Executive Order shall be effective immediately.
