EXECUTIVE ORDER NO. 2016-017

CREATING THE NAGA CITY TRUANCY BOARD (NCTB), DEFINING ITS FUNCTIONS, OPERATIONS, ACCOUNTABILITY, AND APPROPRIATING FUNDS THEREFOR:-

WHEREAS, City Ordinance No. 2004-096 entitled "The Anti-Truancy Ordinance for Elementary Pupils and High School Students in the City of Naga" mandated, among others, the establishment of the Truancy Board;

WHEREAS, City Ordinance No. 2004-096 prescribes the composition of the Board:

WHEREAS, the same City Ordinance prescribes the functions of the Board, to wit:

1. Make responsive and essential the implementation of the Naga City Anti-Truancy Ordinance;
2. Deputize all barangay captains, barangay tanods, BANKAT officers and members, school officials and teachers as action officers in the implementation of this ordinance;
3. Control and prevent juvenile delinquency in order that the health, safety and welfare of students under the age of eighteen and public welfare will be protected;
4. Take active steps in ensuring the welfare of elementary pupils and high school students in the City of Naga;

WHEREAS, the City of Naga, in its continuing commitment to promote the welfare and protection of our children and youth and their future, hereby reaffirms the intent of City Ordinance No. 2004-096 by activating the Naga City Truancy Board;

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers and authority vested in me by law, do hereby order the following:

Section 1. Creation and Purpose- The Naga City Truancy Board, as mandated by City Ordinance No. 2004-096, is hereby created.

Section 2: Composition- The Truancy Board shall be composed of the following:


- City Mayor as Chairman of the Board
- Superintendent, Division of City Schools (or his/her representative) as Vice Chairman of the Board
- Liga ng mga Barangay President, as Member
- Head of TF Ordinance (now TF Comet pursuant to E.O. No. 2016-014), as Member
- President, Pag-iribang Bantay Barangay Federation
- President, BANKAT Federation;

The Task Force Chief of the TF Comet shall be the Chief Operations Officer (COO) of the Board, who shall be primarily responsible for the Anti-Truancy Ordinance's judicious and regular implementation.


Section 5. Funding – The initial operation of the Truancy Board shall be funded from existing appropriations for peace and order. Subsequent funding shall be included in the annual budget of the Education, Sports, and Scholarships Office (ESSO).

Section 6. Effectivity - This order shall take effect immediately.
