EXECUTIVE ORDER NO. 2016-020

**EXECUTIVE ORDER CONSOLIDATING THE GINHAWANG NAGUEÑO
EXECUTIVE ORDERS NO. 2014-019, NO. 2015 001, AND NO. 2015-001-a, AND
AMENDING SOME SECTIONS THEREOF:**

WHEREAS, Nagueños have envisioned Naga to be a place where "Good governance and responsible citizenship (are) driven by a shared development direction crafted, implemented and continually improved in an inclusive manner: and sustained by a citizenry that assert and accept their roles and responsibilities in nation-building; where **People-centered development policies** (are) anchored on quality and accessible services in health, education and other social services, especially for the marginalized and the vulnerable; and enable the private sector to generate the best value from local talents, technology and resources, and provide gainful jobs and entrepreneurial opportunities for the Nagueño; xxx;"

WHEREAS, to fully achieve this, the undersigned City Mayor issued Executive Order No. 2014-019 establishing a framework for the improvement of living conditions in the so-called least economically resilient communities (LERCs) in the City of Naga and creating the LERC Task Force for this purpose;

WHEREAS, in 2015, Executive Order No. 2015-001 was issued and the composition of the said task force amended, putting the City Mayor as Chairperson, SP Committee Head on Urban Poor Affairs as Co-Chairperson, and City Population and Nutrition Officer as Executive Officer. Likewise, Executive Order No. 2015-001-a was issued, further amending EO 2014-019 by officially adopting a name for the LERC program ("Ginhawang Nagueño") and establishing city and barangay technical working groups to expedite its implementation.

WHEREAS, there is a need to consolidate with amendments the aforementioned EOs for easy reference;

NOW THEREFORE, I, JOHN G., BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Definition. As used in this Executive Order, the term "least economically resilient communities" shall refer to contiguous houses or residential area clusters within

Naga City that suffer from inadequacy, or are characterized by any combination of the following living conditions:

- a. With inadequate or no access to basic services particularly power, potable water and/or decent sanitation facilities;
- b. Where majority of the residents do not have regular sources of income or with earnings not sufficient to support the basic needs of families like food, clothing, education, health, and nutrition;
- c. Whose residents are considered as informal settlers, or live along danger zones, or are affected by government projects or court-ordered evictions.

This program shall be known as the "Ginhawang Nagueño Program or GNP of the City Government of Naga"

Section 2. Goal. This program's principal goal is to lay the foundation for all city programs, projects and interventions for the improvement of living conditions in the least economically resilient communities (LERCs). In essence, GNP is an immediate, short-term intervention for long-term and sustainable integration of the "poorest of the poor" into the mainstream government services in particular and into the society in general.

Section 3. Interventions. The City shall implement programs, projects and interventions designed to transform LERCs into livable and decent communities, thus, the city government, through the Task Force created in the subsequent section, shall:

1. Identify residential clusters in the twenty-seven (27) barangays of the city that will fall within the definition of LERCs under section 1 hereof;
2. Organize the residents of the LERCs into homeowners' associations and conduct seminar-workshops for capacity-building, identification of priority interventions, and eventual integration into partner organizations by the city government;
3. Assess the needs of the identified LERCs and identify existing programs of the city government by lead/frontline offices such as, but not limited to, the City Health Office (CHO), City Population and Nutrition office (CPNO), City Social Welfare and Development Office (CSWDO), Housing and Settlements Development Office (HSDO), Water Services Division (WSD) and Public Employment Service Office (Metro PESO);
4. Provide necessary infrastructure and services in the area, where legally possible, and partner with the community residents for the provision of on-site socialized or low-cost

housing, roads/pathwalks, potable water and sanitation facilities via existing or new programs of the city government; provided, except where resettlement would be immediately feasible or would be the best solution under the circumstances;

5. Afford the residents diverse range of employment opportunities, income and/or financial services; and
6. Perform such other functions consistent with or in furtherance of the above.

Section 4. The GNP Management Action Team. In order to address these concerns, a Program Management Action Team is hereby created composed of the following:

- City Mayor, as Chairperson
- SP Committee Head, Committee on Urban Poor Affairs, as Co-Chairperson
- Liga ng mga Barangay President, as Member
- City Population and Nutrition Officer, as Executive Officer
- City Health Officer, as Member
- City Social Welfare and Development Officer, as Member
- City Planning and Development Officer, as Member
- Housing and Settlements Development Officer, as Member
- Solid Waste Management Officer, as Member
- Public Employment and Service Officer, as Member
- City Agriculturist Office, as Member
- Education, Scholarships and Sports Officer or Naga City School Board Administrator, as Member
- I-Serve Information and Action Officer, as Member
- Naga City People's Council Chairperson, as Member

To handle project implementation and administrative aspects of the program, the GNP Task Force is hereby created, to be composed of the following:

- Mr. Eric Jason Salvino, LERC Executive Officer, as Chairperson
- Focal point of the City Social Welfare and Development Office (CSWDO), as member
- Focal point of the Lingkod Barangay Office (LBO), as member
- Focal point of the Housing and Settlements Development Office (HSDO), as member
- Focal point of the City Planning and Development Office (CPDO), as member
- Focal point of the City Environment and Natural Resources Office (ENRO), as member

- Focal Point of the General Services Department
- Head, Naga City Governance Oversight Committee (NCGOC), as member
- Head, Water Services Division (WSD), as member
- President, Metro Naga Chamber of Commerce and Industry (MNCCI), as member
- Head, Community-Based Monitoring System (CBMS), as member
- Representative, Naga City School Board (NCSB) Secretariat, as member
- Representative, Special Concerns Office
- Representative, Gawad Kalinga (GK)

Section 5. Networking and Collaboration. All concerned LGU offices are hereby directed to actively coordinate and cooperate with the GNP Task Force. For this purpose, the GNP Chairperson may call upon or collaborate with national government agencies or even the private sector for assistance, as may be necessary.

The GNP Task Force may likewise access data and information, which it may deem useful and necessary, from the Local Poverty Reduction Action Team.

Section 6. Timetable. The Task Force is given a period of two (2) months, from the date of issuance of this executive order or until August 29, 2016 to submit to the City Mayor its final recommendations and plans including the corresponding timetable for implementation of programs, projects and interventions. After which quarterly update or accomplishments and plan of action shall be submitted by the Task Force to the GNP Management Action Team for review and approval.

Section 7. Office. The GNP PMAT and Task Force shall be allocated sufficient space, office requirements, and utilities to be identified by the City Administrator.

Section 8. Funding. The funding requirements to carry out the mandate of the GNP shall be chargeable against the Special Purpose Appropriations and Local Development Fund. Funds for succeeding years shall be indicated in the annual budget as a separate item, chargeable against the regular appropriations of the Local Development Fund.

Section 9. Separability Clause. Should any provision of this Executive Order be declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.



Section 10. Repealing Clause. All orders, rules, regulations, and issuances or any part thereof, found to be inconsistent with this Executive Order, are hereby deemed repealed or amended, or modified accordingly.

Section 11. Effectivity. This Executive Order shall be effective immediately.
