**EXPANDING AND RECONSTITUTING THE CITY  
ADVISORY COMMITTEE ON OVERSEAS FILIPINOS (CACOF)**

**WHEREAS**, on April 12, 2012, Naga City Mayor John G. Bongat issued Executive Order No. 2012-006 creating the City Advisory Committee on Overseas Filipinos (CACOF);

**WHEREAS**, there is a need to expand its membership especially to respond to emerging needs of the OF sector;

**WHEREAS**, there is a need to reconstitute the CACOF in order to ensure that member(s) who were transferred, promoted or resigned are properly replaced;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the power vested in me do hereby ordain:
