EXECUTIVE ORDER NO. 2016-027

RECONSTITUTING THE NAGA CITY COUNCIL ON DISABILITY AFFAIRS (NCDDA):

WHEREAS, the UN "Convention on the Rights of Persons with Disabilities" recognizes that in order for persons with disabilities to live independently and participate fully in all aspects of life, stakeholders shall take appropriate measures to ensure persons with disabilities' access, on an equal basis with others, to the physical environment, to transportation and communications including information technologies and systems, (Article 9) and to other facilities provided for public;

WHEREAS, the "INCHEON STRATEGY to Make the Rights Real for Persons with Disabilities in the Asia and the Pacific" again reiterates in Goal 3 – the need to enhance physical environment, public transportation, knowledge, information and communications as precondition for persons with disabilities to fulfill their rights in an inclusive society;

WHEREAS, Batas Pambansa Blg. 344 and RA 7277, otherwise known as the Magna Carta for Persons with Disabilities, recognize that in order to promote the realization of the rights of persons with disabilities to participate fully in the social life and development and enjoyment of opportunities available to other citizens in their respective communities, it is imperative to comply with the accessibility requirements;

WHEREAS, despite all these agreements, policies and laws both here and globally, implementation of these laws remains inadequate and enjoys low compliance;

WHEREAS, despite the fact that the National Council on Disability Affairs through its Sub-Committee on Accessibility led by the Department of Public Works and Highways (DPWH) has been conducting a series of seminars, accessibility talk-shops, and workshops to capacitate our stakeholders; still we have to include our persons with disabilities in our City and District Engineering Offices in monitoring and accessing audits to spur full enforcement of the Accessibility Law;

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested to me by law, do hereby order:

Section 1. Creation. In order to address the aforementioned concerns, the Naga City Council on Disability Affairs (NCCDA) is hereby reconstituted.

Section 3. Functions.

3.1. COMMITTEE ON ADVOCACY

1. Promote the alignment of policies and programs pertaining to livelihood, training, employment, accessibility and rehabilitation of PWDs as contemplated in the Magna Carta for Persons with Disability and other relevant laws;

3.2. COMMITTEE ON ACCESSIBILTY

- 1. Organize access Monitoring Team that shall conduct access audit in the city;
- 2. Provide Technical Assistance to requesting sectors relative to accessibility law, creation of non-handicapping environment and universal design;
- 3. Enforce, monitor and conduct access audits relative to the provisions of BP 344 and its Implementing Rules and Regulations in compliance with the Accessibility Law;
- 4. Monitor PUVs that are using terminals inside the City, in coordination with the LTO, LTFRB, and PSO, to ensure that designated reserved seats for PWDs carry the "moving forward" international accessibility symbol;
- 5. Ensure that the private/public buildings intended for public use (including worship places) have facilities designated for PWDs (e.g. parking area, ramp, comfort rooms, etc.) in coordination with the City Engineer's Office and DPWH, and shall display the said symbol:

- 6. Recommend to NCDA thru the NCCDA, the filing of appropriate legal action against violators of BP 344 and RA 7277; and
- 7. Perform other duties and functions as requested by the NCDA Board, other Committees, and sectors of persons with disabilities and concerned individuals.

3.3. COMMITTEE ON LIVELIHOOD, TRAINING and EMPLOYMENT

- 1. Provide assistance in the sustainable development of persons with disabilities through establishment and institutionalization of livelihood, training and employment programs and strategic economic development;
- 2. Assist PWDs in identifying training needs and other employment-related assistance necessary to prepare them socially and economically;
- 3. Assist in monitoring and evaluating the implementation of the assisted PWD training programs and livelihood projects.

3.4. SECRETARIAT

1. Keep in custody all the documents and records pertaining to NCCDA and perform other functions as prescribed by the council.

Section 4. Repealing Clause. All issuances inconsistent with this Executive Order are hereby repealed and/or modified accordingly.

Section 5. Effectivity. This Executive Order shall take effect immediately.
