**EXECUTIVE ORDER NO. 2016-031**

**RECONSTITUTING THE NAGA CITY URBAN DEVELOPMENT AND HOUSING BOARD (NCUDHB):**

**WHEREAS**, Section 8, Article 6 of Ordinance No. 98-033 mandates the creation of the Naga City Urban Development and Housing Board (NCUDHB) which acts as the city's arm in the implementation and monitoring of pertinent provisions of Republic Act No. 7279 and ordinance No. 98-003;

**WHEREAS**, the same section speaks of appointment by the City Mayor of Board Members from the private sector;

**WHEREAS**, received by the Office of the City Mayor on 2 August 2016 is a letter dated 1 August 2016 from Mr. Johann P. De La Rosa, Executive Director of the Naga City People's Council and noted by Dr. Augusto R. Nieves, Chairperson of the same, endorsing the list of five (5) city accredited non-government organizations to represent their sector in the Board;

**WHEREAS**, there is also a change of representation from the Liga ng mga Barangay to be represented by the new Liga President, Hon. Tomas Ramon A. Sanchez;

**WHEREAS**, in order to rectify this, there is a need to re-organize specifically, the composition of the Naga City Urban Development and Housing Board's non-government organization representatives and the representatives from the Liga ng mga Barangay so that the Board can effectively carry out its functions for the good and welfare of the constituents of the City of Naga;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by Law, do hereby order the reconstitution of the Naga City Urban Development and Housing Board (NCUDHB) to be composed of the following:

**Section 1. Composition.** The Naga City Urban Development and Housing Board (NCUDHB) is hereby reorganized, now to be composed of the following:

From the government sector

- Hon. Mila S.D. Raquid- Arroyo, Chairperson, SP Committee on Urban Poor Affairs, and Co-Chairperson and Presiding Officer of the Board

**Section 2. Term of Office.** The members of the Board shall serve for a term to expire noon of June 30, 2019, unless sooner terminated for cause, provided that only representatives from the urban poor federation, non-government organizations and people's organizations with no previous conviction or pending cases of crimes involving moral turpitude, and recommended by the Naga City People's Council may be appointed.

**Section 3. Schedule of Meeting.** The Board shall have a regular meeting once a month which will be in the afternoon of every **First Tuesday** of the month and every month thereafter. The Chairperson may call on a special meeting after its regular monthly meeting if there are issues that need immediate disposition by the Board;

**Section 4. Rules of Procedure.** The board shall choose a chairperson from among themselves and promulgate its own internal rules of procedure.


**Section 5. Termination.** The City Mayor shall, upon recommendation of the urban poor federation or organization or non-government organizations concerned, terminate the appointment of any member on any just or valid cause.

**Section 6.** This Executive Order Shall be effective immediately.
