**Executive Order No. 2016-038**

**CREATING THE TASK FORCE KATAID AND PROVIDING MECHANICS FOR  
THE OPERATIONS THEREOF:-**

**WHEREAS**, Naga City has institutionalized anti-drug abuse programs since 2001 thru City Ordinance 2001-064 entitled "An Ordinance Creating the Naga City Dangerous Drugs Board (NCDDDB) and Appropriating Funds Therefor" authored by then City councilor and now incumbent Mayor John G. Bongat;

**WHEREAS**, in support of the national anti-drugs program launched by the Duterte administration and the inflow of hundreds of individuals voluntarily submitting themselves to the government as drug users and pushers, Naga City launched the "Salvar-Buhay: Reintegration Program for Illegal Drug Users and Pushers" which provided comprehensive LGU-led interventions in the areas of enforcement, treatment and rehabilitation, livelihood, as well as barangay-level programs;

**WHEREAS**, the Department of the Interior and Local Government (DILG) recently created the inter-agency task force called DILG Inter-Government Operations Network Group or DIGONG tasked, among others, to assist in processing the surrender of individuals involved in illegal drugs, through coordination with the PNP, and refer the surrenderees to rehabilitation centers.

**WHEREAS**, the DILG RO5 also issued Regional Memorandum Circular No. 2016-015 mandating the creation of Task Force KAbarangayko, TAtabangankongIwasan an Droga (KATAID) to perform the following responsibilities:

1. Provide full support to OPLAN TOKHANG being spearheaded by the PNP;
2. Ensure that the process in handling Surrendering Drug Users (SDU's) will be implemented properly;
3. Identify issues/concerns and actions to be taken at the local level;
4. Study strategic options for the convergence of delivery of basic services;
5. Make recommendations to higher level to address pressing issues; and
6. Ensure the integration of the P/P/As of the Task Force in the Peace and Order and Public Safety (POPS) Plan of the R/P/C/M/BPOC and allocate funds for such.

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. CREATION.** There is hereby created the Task Force KABarangayko, Tatabangan kong Iwasan an Droga (KATAID) with the following composition:

- City Mayor, TF KATAID Chairperson
- City Councilor, Liga ng mga Barangay President
- CLGOO-DILG
- City Health Officer
- PNP-Naga City Director
- City Social Welfare Officer
- Schools Division Superintendent or his representative

A counterpart TF KATAID in the twenty-seven (27) barangays of the city is also directed to be set up with the following composition:

- Punong Barangay as Chairperson
- Chief Tanod
- Barangay Health Worker
- Public School Principal/s (of public elementary and high schools, if any, located within the barangay)
- Heads of Religious Organizations existing in the barangay

**Section 2. FOCAL PERSON.** The NCDDDB Executive Director is hereby designated as the LGU focal person for the TASK FORCE KATAID.

**Section 3. SECRETARIAT.** There shall be a Task Force Secretariat to be headed by the CLGOO-DILG which shall perform the following functions:

1. Provide Administrative/support services/document proceedings of meetings and other related activities of the TF;
2. Coordinate with appropriate government agencies;
3. Submit reports required by higher levels; and
4. Perform other related tasks assigned from time to time.

The Barangay Secretary shall provide administrative support to the Task Force in their respective barangays.

**Section 4. FUNCTIONS.** As mandated by DILG RO5 Regional Memorandum Circular No. 2016-015, the TASK FORCE KATAID shall perform the following functions:

1. Provide full support to GPLAN TOKHANG being spearheaded by the PNP;
2. Ensure that the process in handling SDU's will be implemented properly;
3. Identify issues/concerns and actions to be taken at the local level;



4. Study strategic options for the convergence of delivery of basic services;
5. Make recommendations to higher level to address pressing issues; and

7. Provide full support to OPLAN TOKHANG being spearheaded by the PNP;

9. Identify issues/concerns and actions to be taken at the local level;
10. Study strategic options for the convergence of delivery of basic services;
11. Make recommendations to higher level to address pressing issues; and
12. Ensure the integration of the P/P/As of the Task Force in the Peace and Order and Public Safety (POPS) Plan of the R/P/C/M/BPOC and allocate funds for such.
