Executive Order No. 2016-041

**RECONSTITUTING THE WORKING COMMITTEES OF THE
KAMUNDAGAN FESTIVAL IN THE CITY OF NAGA:**

WHEREAS, the Kamundagan Festival is a month-long celebration in the City of Naga which commemorates the Birth of Christ;

WHEREAS, it is an annual festivity of the city which features its tradition and cultures while showcasing the values that shaped the customs of every Nagueño;

WHEREAS, there is a need to create groups that shall plan and implement programs and activities to ensure the proper observance of the aforementioned festival, the smooth flow of its activities as well as documentation and generation of the necessary reports after the festival;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order:

Section 1. Creation. In order to address the aforementioned points, the City of Naga Kamundagan Festival Executive Committee and Technical Working Group (TWG) are hereby created.

Section 2. Composition. The City of Naga Kamundagan Festival Executive Committee and TWG shall be comprised of the following:

Section 3. Functions and Responsibilities. The Kamundagan Festival Executive Committee and TWG shall have the following functions and responsibilities:

EXECUTIVE COMMITTEE:

- a. Formulate, plan and implement appropriate programs and activities to ensure the successful observance of the festival;
- b. Oversee the over-all implementation of programs and activities of the festival particularly the enhancement of the plazas and other public places, the parade, etc.;
- c. Ensure the active participation of all concerned during the month-long celebration;
- d. Perform such other functions in accordance with this Executive Order.

TECHNICAL WORKING GROUP (TWG):

- a. Perform the technical legwork in consonance with the plans and programs of the Executive Committee;
- b. Regularly coordinate with the Executive Committee;
- c. Perform such other functions in accordance with this Executive Order.




