EXECUTIVE ORDER NO. 2016-043

INSTITUTIONALIZING INITIATIVES TOWARD BICYCLE-FRIENDLY NAGA CITY BY ESTABLISHING APPROPRIATE PROGRAMS AND PROJECTS, IMPLEMENTATION MECHANISMS, AND FUNDING THEREFOR :

WHEREAS, Section 16, Chapter 2 of the Local Government Code (RA 7160) mandates local government units to ensure effective and efficient governance toward the promotion of general welfare ;

WHEREAS, City Ordinance No. 2008-068 mandated the designation of safe and convenient bicycle and motorcycle parking spaces for bicycles and motorcycles at the city's business districts by providing facilities such as bicycle racks and iron hooks;

WHEREAS, the National Bicycle Organization has also drafted an initiative to standardize the definition of bicycle-friendly private and government buildings, offices, companies in the Philippines;

WHEREAS, there is a need to coordinate the implementation of these policies and initiatives to ensure immediate and effective implementation in Naga City;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the constitution of the Naga City Bicycle-Friendly Task Force (BF TASK FORCE):

Section 1. Composition. The BF Task Force is hereby constituted with the following as members: 1. City ENRO, TF Chairman 2. PSO, TF Vice Chairman 3. TF COMET 4. CEPPIO 5. City Engineer's Office

Section 2. Functions. 1. Ensure the implementation of City Ordinance No. 2008-068; 2. Initiate the implementation of the National Bicycle Organization rating system; 3. Plan and manage the "Bike Festival" scheduled on November 12, 2016; 4. Conduct monthly planning and assessment on the bike-friendly Naga City initiatives; 4. Provide the City Mayor with monthly updates on the implementation status, accomplishments and constraints

Section 3. Funding. Funding for the BF Task Force activities shall be sourced from existing allocations of the PSO, City ssssssENRO, CEPPIO, and CEO. A more detailed plan shall be drafted by the BF Task Force for inclusion in the 2017 budget.


This Executive Order Shall be effective immediately.
