**EXECUTIVE ORDER NO. 2016-047**

**ESTABLISHING THE RAUL S. ROCO – NAGA CITY PUBLIC LIBRARY (RNCPL) STANDARDIZATION COMMITTEE, DESIGNATING ITS MEMBERS, DEFINING ITS FUNCTIONS, AND PROVIDING FUNDS THEREFOR:**

**WHEREAS**, City Ordinance 2016 – 036 mandated that the local library established as the Provincial Public Library in 1921, re-established as the City Public Library in 1957, renamed as the Raul S. Roco Library in 2005, shall henceforth be known as the Raul S. Roco – Naga City Public Library (RNCPL);

**WHEREAS**, City Ordinance No. 2016-036 also mandated the establishment of the RNCPL Standardization Committee to annually evaluate and recommend improvements toward standardization of the library;

**WHEREAS**, it is imperative that the RNCPL meet the minimum requirements in the Standards for Public Libraries prescribed by the Philippine Board of Librarians – Professional Regulations Commission;

**NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by Law**, do hereby order the establishment of the RAUL S. ROCO – NAGA CITY PUBLIC LIBRARY (RNCPL) STANDARDIZATION COMMITTEE.

**Section 1. Composition.** The RNCPL Standardization Committee shall be composed of the following:

**Section 2. Functions.**

1. Using the Standards for Public Libraries or any veritable evaluation instrument available, the Committee shall submit its first evaluation report not later than 1 December 2016.

Analysis, evaluation, and recommendations shall be part of the 2016 report.


2. Succeeding reports due every 1 December every year shall incorporate a section re “actions taken on previous recommendations.”

3. Should RNCPL receive a “satisfactory” rating by 2019, it shall be evaluated by the Committee every three years. Otherwise, it shall be evaluated annually for the items where it got “below satisfactory” rating


**Section 3. Funding.** Funding for the RNCPL Standardization Committee shall be sourced from existing allocations of the RNCPL. A more detailed plan shall be drafted by the RNCPL for inclusion in the 2017 budget.

This Executive Order Shall be effective immediately.
