**Executive Order No. 2016-049**

**RECONSTITUTING THE NAGA CITY PROJECT MONITORING COMMITTEE (PMC) AND ITS TECHNICAL WORKING GROUP AND SECRETARIAT:-**

**WHEREAS**, Executive Order No. 376, series of 1989, as amended by Executive Order No. 93, dated June 1, 1993, a City Project Monitoring Committee must be constituted to monitor all foreign and nationally-funded projects, including development projects funded from the Internal Revenue Allotment (IRA) share of local government units or supported by funds released directly to the City Government and projects funded from locally-generated resources which are implemented within the territorial jurisdiction of Naga City;

**WHEREAS**, there is a need to reconstitute the Naga City Project Monitoring Council in order to ensure that member(s) who were transferred, promoted or resigned are properly replaced;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby ordain the following:

**SECTION 3. FUNDING.** The operation of the City Project Monitoring Committee shall be provided with a yearly budget taken from the 20% Local Development Fund.


