EXECUTIVE ORDER NO. 2017-013

**CREATING THE NAGA CITY PLATINUM CHARTER ANNIVERSARY
PREPARATORY COMMITTEE (PREPCOM), DEFINING ITS COMPOSITION
AND FUNCTIONS:**

WHEREAS, Naga City was declared a Chartered City on June 18, 1948 by virtue of Republic Act No. 305 authored by then Rep. Juan Q. Miranda;

WHEREAS, the 70th Platinum Anniversary of Naga City as an independent component city of the country will be on June 18, 2018;

WHEREAS, there is a need for coordinated planning to ensure smooth implementation of the activities in connection with this historic celebration;

WHEREAS, the City Government is continuously committed to the celebration and preservation of the historical milestones and vital periods in the development of Naga City;

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Creation and Purposes. The Naga City Platinum Charter Anniversary Committee is hereby established to plan and implement the forthcoming celebration of the Naga City Platinum Anniversary.

Section 2. Composition. The Naga City Platinum Anniversary Preparatory Committee shall be composed of the following:

Section 3. POWERS AND FUNCTIONS - The Committee shall have the following functions and responsibilities:

- a. Formulate, plan, and implement appropriate programs and activities for the Naga City Platinum Anniversary in 2018;
- b. Oversee the over-all implementation of programs and activities;
- c. Ensure the active participation of all stakeholders from the private and government sector;
- d. Coordinate with the Naga City Museum Preparatory Committee created pursuant to EO2017-001A re the formal launching of the Naga City Museum;
- e. Make preparations for the formal hoisting of Barangay Official Flags of the 27 barangays of the city in permanent flagpoles to be installed in City Hall; and
- f. Perform such other functions in accordance with this Executive Order.

Section 4. Budgetary requirements for the Committee's operation shall be sourced from existing appropriations for infrastructure and of involved offices.

Section 5. All issuances and orders inconsistent with this Executive Order are hereby repealed, amended and/or modified accordingly.
