Executive Order No. 2017 - 022

**AMENDING EXECUTIVE ORDER NO. 2017-004, SECTION 4
"COMPOSITION" BY INCLUDING THEREIN PHILIPPINE COCONUT
AUTHORITY (PCA) AND PHILIPPINE FIBER DEVELOPMENT (PhilFIDA).**

WHEREAS, Executive Order No. 2017 – 004 otherwise known as “CREATING THE INTER-AGENCY TASK FORCE FOR THE DEVELOPMENT, IMPLEMENTATION AND SUSTAINABILITY OF LIVELIHOOD PROJECTS FOR THE PANICUASON FARMERS’ ASSOCIATION, AND DEFINING ITS FUNCTIONS AND COMPOSITIONS” was issued on the 6th day of February 2017;

WHEREAS, the Philippine Coconut Authority (PCA) and Philippine Fiber Development Authority (PhilFIDA) are two main agencies will help the City Government of Naga to further galvanize programs and enhance projects that will improve the socio-economic welfare of Panicuason Farmers’ Association and its beneficiaries;

WHEREAS, thru inter-agency collaboration, a harmonized effort involving the City Government offices and national government agencies with livelihood and micro – enterprise development programs to support, develop and sustain the livelihood activities of the Panicuason Farmers’ Association can be a model for the development of similar projects for other barangays and / or beneficiary groups in the city;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the power vested in me by law, do hereby order:

Section 4, as amended shall now read thus. **“SECTION 4. COMPOSITION.** The IATF shall be composed of the following:

Chairman : City Mayor

Vice Chairman and Executive Officer : Head, Metro PESO


Members:

- a. City Agriculturist
- b. Barangay GrOW Account Officer from Metro PESO
- c. Arts, Culture and Tourism Officer

- d. Executive Officer of the Naga City School Board
- e. Representative from the Department of Agrarian Reform
- f. Representative from the Department of Trade and Industry
- g. Representative from the Department of Science and Technology
- h. Representative from the Philippine Coconut Authority
- i. Representative from the Philippine Fiber Development Authority”

This Executive Order shall take effect immediately.
