AMENDING SECTION 1 – ARTICLE II OF EXECUTIVE NO. 2013 – 0016 FOR THE PURPOSE OF INCLUDING THE HEAD OF THE METRO NAGA WATER DISTRICT (MNWD) IN THE NAGA CITY NUTRITION COUNCIL: -

WHEREAS, Executive Order No. 2013 -0016 was issued on July 03, 2013, otherwise known as “REORGANIZING AND EXPANDING THE MEMBERSHIP OF THE NAGA HEALTH BOARD AND NAGA CITY NUTRITION CONCIL”;

WHEREAS, Resolution No. 2017 – 01 of the Sangguniang Panlungsod, also known as the “RESOLUTION EARNESTLY REQUESTING HIS HONOR, THE CITY MAYOR TO AMEND EXECUTIVE ORDER 2013-0016 BY ADDING IN THE MEMBERSHIP OF THE NAGA CITY NUTRITION COMMITTEE THE HEAD OF THE METRO NAGA WATER DISTRICT (MNWD) IN THE CITY OF NAGA” was submitted to the Office of the City Mayor;

WHEREAS, Section 1 of Article II of the said executive order will be amended for the purpose of including Metro Naga Water District (MNWD) in the Naga City Nutrition Council;

WHEREAS, Metro Naga Water District (MNWD) will help the Naga City Nutrition Council in giving essential information on the quality and cleanliness of water supply given to the Nagueños;

WHEREAS, the Council is responsible in planning, implementing, consolidating and evaluating sound nutrition action programs;

Now therefore, I, John G. Bongat, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order, amendment of Article II of Executive Order No. 2013 – 0016 to read as follows:

ARTICLE II – NAGA CITY NUTRITION COUNCIL


