**AMENDING SECTION 1 OF EXECUTIVE NO. 2017-001-A FOR THE PURPOSE OF INCLUDING HISTORIAN DANILO M. GERONA OF NUEVA CACERES HERITAGE MOVEMENT, INC. (NCHMI) IN THE NAGA CITY MUSEUM PREPARATORY COMMITTEE (PREPCOM) - TECHNICAL WORKING GROUP: -**

**WHEREAS**, Executive Order No. 2017-001-A was issued on 06 February 2017;

**WHEREAS**, Section 1 of the said executive order will be amended for the purpose of including historian Danilo M. Gerona of Nueva Caceres Heritage Movement, Inc (NCHMI) in the Naga City Museum Preparatory Committee (PrepCom) - Technical Working Group;

**WHEREAS**, the Nueva Caceres Heritage Movement, Inc. (NCHMI) was established in 2013 for the advancement of general heritage consciousness and undertake initial steps in the protection, preservation and restoration of heritage structures and sites as well as cultural heritage in the city and suburban communities;

**WHEREAS**, historian Danilo M. Gerona is an active member of Nueva Caceres Heritage Movement, Inc (NCHMI) who manifested his interest and willingness to become part of the said preparatory committee;

**Now therefore, I, John G. Bongat**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the amendment of Section 1 of Executive Order No. 2017-001-A to read as follows:

**Section 1. Creation and Composition.** - The NAGA CITY MUSEUM PREPARATORY COMMITTEE, otherwise called NAGA CITY MUSEUM PREPCOM is hereby created to be headed by the City Mayor as Chairman and the Chairman of the SP Committee on Culture as Executive Officer, with representatives from the city offices, from the academe and the private sector as members, to wit:

- a. Project Development Officer, City Mayor's Office
- b. Acting Director, Technical and Publications Division, Sangguniang Panlungsod
- c. Arts, Culture and Tourism Office
- d. City Events, Protocol and Public Information Office

- e. Education, Sports and Scholarships Office
- f. Raul S. Roco Library
- g. Department of Education
- h. Naga City People's Council
- i. Metro Naga Development Council – Adolfo Badiola, Jr.
- j. Private Sector - Mr. Antonio Amparado
- k. Nueva Caceres Heritage Movement, Inc. – Danilo M. Gerona

This Executive Order shall take effect immediately.
