**EXECUTIVE ORDER NO. 2017-032**

**ESTABLISHING THE NAGA CITY RESILIENCE COUNCIL (NCRC), DEFINING ITS COMPOSITION AND FUNCTIONS:-**

**WHEREAS**, the National Resilience Council (NRC) was launched last October 13, 2017 in support of the 2017 International Day for Disaster Risk Reduction (DRR);

**WHEREAS**, the NRC aims to have public-private partnership working together making the country resilient to disasters and focused on one of the seven Global Targets of the Sendai Framework: *To substantially reduce the number of affected people globally from disasters by 2030*;

**WHEREAS**, Naga City is one of the stakeholders who pledged to work with the NRC and pursue the continuing agenda to build a resilient Philippines;

**WHEREAS**, there is a need to create a counterpart local council to be known as the Naga City Resilience Council (NCRC) to coordinate local efforts and to further realize the goals and objectives of the National Resilience Council in the local level;

**NOW, THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. - CREATION AND PURPOSES.** - The Naga City Resilience Council (NCRC) is hereby established to plan and to implement projects, and programs for a resilient Naga City.

**SECTION 2. - COMPOSITION.** - The Naga City Resilience Council (NCRC) shall be composed of the following;

Chairman: Public Safety Office (PSO)  
Members: City Disaster Risk Reduction and Management Office (CDRRMO)  
City Planning and Development Office (CPDO)  
City Events Protocol and Public Information Office (CEPPIO)  
Central Communication Center (COMCEN)  
City Social and Welfare Development (CSWDO)  
Education, Sports, and Scholarships Office (ESSO)  
City Health Office (CHO)  
City Environment and Natural Resources Office (City ENRO)  
Metro Naga Public Employment and Service Office (METRO PESO)  
Housing and Settlements Development Office (HSDO)

Naga City People's Council (NCPC)  
Rotary Club of Naga East  
Metro Naga Chamber of Commerce and Industry (MNCCI)  
SM City Naga  
Institute for Environmental Conservation and Research (INECAR)

**SECTION 3. - POWERS AND FUNCTIONS.** The Council shall have the following functions and responsibilities:


1. Ensure disaster resiliency and effective response in Naga City;
2. Understand disaster in all its dimensions of vulnerability, capacity, exposure of persons and assets, hazard characteristics and the environment in the city;
3. Strengthen disaster risk governance to manage disaster risk at the local level through collaboration and partnership;
4. Invest in disaster risk reduction for resilience of persons, communities and their assets, as well as the environment by investing on the economic, social, health and cultural dimensions;
5. Enhance disaster preparedness for effective response and to "Build Back Better" in recovery, rehabilitation and reconstruction by taking proactive action and by ensuring that capacities are in place at all levels through integrating disaster risk reduction into development measures; and
6. Coordinate with the NRC regarding LGU performance of resilience indicators; and
7. Performing other functions as may be necessary.

**SECTION 4. - BUDGET.** Budgetary requirements for the Council's operations shall be sourced from the existing appropriations for projects and programs and of involved offices.


**SECTION 5. EFFECTIVITY.** All issuance and orders inconsistent with this Executive Order are hereby repealed, amended and/or modified accordingly.
