**EXECUTIVE ORDER NO. 2018 - 006**

**UPDATING THE COUNCIL MEMBERS OF THE CITY ANTI - DRUG ABUSE COUNCIL UNDER EXECUTIVE ORDER 2016 - 054:-**

**WHEREAS**, the Executive Order 2016 - 054 was issued on December 01, 2016 under the mandates of the Constitution in which the government shall promote the quality life of people;

**WHEREAS**, in consonance to the Section 16 of the Local Government Code of 1991, the local government units shall pursue undertaking to improve public morals and maintain peace and order, among other equally significant concerns;

**WHEREAS**, under the City Ordinance 2001 - 064, the Naga City Dangerous Drugs Board (NCDDDB) was established and the City Anti - Drugs Abuse Council (CADAC) pursuant to DILG Memorandum Circular No. 98 -227, shall function as the local over-all consultative, multi-sectoral body that will serve as the exclusive policy - making, monitoring and coordinating of the existing and recommended programs, and projects in relation to the ordinances, memoranda of the city;

**WHEREAS**, the Council will formulate and implement short-term, long term and sustainable solutions to the persistent drug problem and rehabilitation program of the city.

NOW, THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga City by virtue of the powers vested in me by law do hereby order the updating the council members of the City Anti - Drug and Abuse Council (CADAC).

**SECTION 2. DUTIES AND FUNCTIONS** – The City Anti - Drug and Abuse Council shall perform the following;

- a. Pursue an intensive and unrelenting campaign against the trafficking and use of dangerous drugs and other similar substance through an integrated system of planning, implementation and enforcement of anti – drug campaign;
- b. Plan, strategize, implement and evaluate programs on prevention and rehabilitation programs;
- c. Coordinate and collaborate with other institutions implementing programs and projects on drug abuse at the city level;
- d. Initiate the conduct of symposia and dialogues with school authorities and students, owners and employees of business establishments, government officials and employees and the general public;
- e. Ensure the sustainability of rehabilitation or treatment programs of drug dependence;
- f. Cause the enactment of an ordinance implementing the Comprehensive Dangerous Drugs Act;


- g. Continuously gather and update data on drug abuse and its effect on the peace and order situation in the city including listing of drug personalities;
- h. Submit a monthly report to Local Chief Executive, NCDDDB and to DILG;
- i. Ensure that the Punong Barangays shall perform their responsibilities as embodied in DILG Memorandum Circular No. 2015 – 63; and
- j. Ensure the provision of Sections 51 and 53 of Republic Act 9165 Comprehensive Dangerous Act 2002 shall be strictly observed.

**SECTION 3. MEETING** – The Council shall meet quarterly or at any date that shall be determined by the council.

**SECTION 4. EFFECTIVITY** – All issuance and orders inconsistent with this Executive Order are hereby repealed, amended and/or modified accordingly.
