**EXECUTIVE ORDER NO. 2018-014**

**RECONSTITUTING THE NAGA CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL**

**WHEREAS**, RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 and its implementing rules and regulations mandates the creation of the Local Disaster Risk Reduction and Management Council (CDRRMC) in every local government unit;

**WHEREAS**, the City Government aligns itself to the National Government's policy to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated, proactive and participative especially at the local community level;

**WHEREAS**, the recent local elections requires reconstitution of the CDRRMC due to the end of term of office of former CDRRMC members and other identified needs for improvement;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. Composition.** The Naga City Disaster Risk Reduction and Management Council is hereby reconstituted to be composed of the following:

**Section 2. Secretariat.** The Council Secretariat shall be composed by the following personnel:

**Section 3. Meetings and Quorum.** The meeting of the Council shall be held once every three (3) months on the dates and place determined by the body. The Local Chief Executive, as Chairperson may call for a special meeting as he may deem necessary. The presence of one-third (1/3) of the members shall constitute a quorum for the transaction of business at any meeting of the Council.

**Section 4. Effectivity.** This Executive Order shall take effect immediately.
