Executive Order 2018 - 020

**CREATING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN TEAM
OF THE CITY OF NAGA:-**

WHEREAS, pursuant to the Department Order No. 2017-011 or the “Omnibus Planning and Identification of Public Road Transportation Services and Franchise Issuance” of the Department of Transportation (DOTr) which recognizes the subsidiarity principle that LGUs are in better position to identify local public transport service requirements and formulate plans for improving connectivity between and among their urban and rural socio-economic activities; LGUs, under the guidance of DOTr, are responsible for collecting data, analyzing public transport supply and demand, and identifying specific public transport supply gaps for travel within their territories and for capturing this in city public transport plans or in the form of the Local Public Transport Route Plan (LPTRP);

WHEREAS, under the Department Order No. 2017-011, the Local Public Transport Route Plan (LPTRP) shall be a minimum requirement of the LTFRB prior to the issuance of franchises;

WHEREAS, under the DILG-DOTC Joint Memorandum Circular No. 01, Series of 2008, dated 10 September 2008, entitled “Guidelines in the Review of Local Ordinances, Orders, Rules and Regulations concerning Public Transportation”, the Department of the Interior and Local Government (DILG) may establish and prescribe rules, regulations, and other issuance to ensure that locally-issued ordinances, orders, rules and regulations concerning public transportation conform with existing laws and jurisprudence relating to public transportation;

WHEREAS, under the Joint Memorandum Circular No. 001, Series of 2017, dated 19 June 2017, the DILG and DOTr mandated the Provincial, City, Municipal Governments, Autonomous Regions, Special Areas, and Regional offices of the DILG and the DOTR thru the Land Transportation Franchising and Regulatory Board (LTFRB) nationwide to Prepare and issue local ordinances concerning the Local Public Transport Route Plan (LPTRP); and

WHEREAS, there is a need to create the Local Public Transport Route Plan Team (LPTRPT) to carry on the mandate given by DOTr, LTFRB and DILG to create the Local Public Transport Plan of the City.

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. - COMPOSITION. - The Local Public Transport Route Plan Team of Naga shall be composed of the following:

Chairman: City Mayor
Vice Chairman: Sangguniang Panglungsod Councilor, Head of the Committee on Public Utilities
Members: Head, Public Safety Office (PSO) and Naga City Resilience Council (NCRC)
City Planning and Development Office (CPDO)
PISTON
Philippine National Police (PNP)
SP Trimobile Task Force
City Engineer's Office
City Agriculture Office
ACTO
City Director of the Naga City Police Office
Representative from Association of Barangay Council (ABC)
Representative from DPWH District Office
Representative from LTO
Representative from LTFRB
Representative from Naga City Peoples Council (NCPC)

SECTION 2. - DUTIES AND RESPONSIBILITIES. - The Team shall be responsible in:

1. Prepare the Local Public Transport Plan (LPTRP) based on and/or consistent to the Manual provided by the DOTr
2. Submit the aforementioned plan to the Land Transportation Franchising and Regulatory Board (LTFRB) for review, copy furnished the Department of Interior and Local Government (DILG), within six months from the formal notice of the DOTr.
3. Conduct a yearly monitoring after the implementation of the LPTRP.
4. Update and revise LPTRP as needed.

SECTION 3. - FUNDING. - The City Budget Office is directed to identify appropriate source of fund to support the LPTRP Team, subject to submission of a work and financial plan.


SECTION 4. - EFFECTIVITY. - This Executive Order shall take effect immediately.
