EXECUTIVE ORDER NO. 2019-001

**RECONSTITUTING THE NAGA CITY DISASTER AND RISK
REDUCTION MANAGEMENT COUNCIL**

WHEREAS, RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 and its implementing rules and regulations mandates the creation of the Local Disaster Risk Reduction and Management Council (CDRRMC) in every local government unit;

WHEREAS, the City Government aligns itself to the National Government's policy to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated, proactive and participative especially at the local community level;

WHEREAS, the recent local elections requires reconstitution of the CDRRMC due to the end of term of office of former CDRRMC members;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:
