EXECUTIVE ORDER NO. 2019-002

CONSTITUTING THE INTER-AGENCY COMMITTEE FOR THE CELEBRATION OF THE FEAST OF SEÑOR JESUS NAZARENO AND SANTO NIÑO IN THE CITY OF NAGA:-

WHEREAS, the City of Naga annually celebrates, together with our Filipino brethren in Manila, the Feast of Señor Jesus Nazareno and, with the brethren in Cebu, Iloilo and Aklan, the Feast of Señor Sto. Niño with various civic events;

WHEREAS, the State, pursuant to the Philippine Constitution and recognizing its duties and responsibilities, as expressly prescribed in Section 15, Article 14 thereof, and cognizant of the contributions of the Feasts of Jesus Nazareno and Sto. Niño to the local economy, regardless of religion, promotes peace and order, provide an environment conducive to tourism, a venue for appreciation of indigenous arts and culture;

WHEREAS, there is a need to create an inter-agency committee to tasked to develop an effective and efficient command, control, coordination, collaboration and communication system of the Festivities;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. CREATION. An Inter-Agency Committee for the Celebration of the Feasts of Señor Jesus Nazareno and Señor Santo Niño is hereby constituted to be composed of the following:

Section 2. FUNCTIONS. The Inter-Agency Committee shall have the following functions:

- a. Ensure successful staging of the various activities of the two festivities;
- b. Pool vital resources and supervise security, public safety, health and sanitation, emergency response and disaster preparedness operations;
- c. Carry out the principles of emergency preparedness and emergency management, or disaster management function at a strategic level in an emergency situation;
- d. Establish a command, control, coordination and collaboration, and communication systems for the over-all disaster emergency response;
- e. Implement plans and programs, provide security and public safety, address threats to internal security and safety, fire suppression, respond to all kind of emergencies and implement disaster preparedness mechanisms for natural, manmade, human induced hazards, HAZMAT response and bio hazard threats;
- f. Call upon other government departments and agencies, and other non-government organizations for

- assistance and support for the successful implementation of the objectives of this Executive Order;
- g. Create committees as it may deem necessary to carry out the objectives of this Executive Order.


Section 3. EFFECTIVITY. This Executive Order shall be effective immediately
