**EXECUTIVE ORDER 2019 - 005**

**RECONSTITUTING CITY AWARDS COMMITTEE FOR OUTSTANDING LUPONG  
TAGAPAMAYAPA OF NAGA CITY:-**

**WHEREAS**, Lupong Tagapamayapa was created under Presidential Decree 1508 on June 11, 1978 to amicably settle the interpersonal disputes at the barangay level to effect the speedy administration of justice;

**WHEREAS**, Chapter VII, Section 399a of the Local Government Code (RA 7160) emphasizes that every barangay must create a lupong tagapamayapa headed by the punong barangay with ten (10) to twenty (20) members;

**WHEREAS**, Executive Order No. 394, Series of 1997 established the Lupong Tagapamayapa Incentives Award (LTIA) consistent with Section 406b of the Local Government Code 1991,

**WHEREAS**, the Outstanding Lupong Tagapamayapa will generate awareness to various sectors of Naga City regarding Katarungang Pambarangay as an effective avenue towards social ordering and human development;

**NOW THEREFORE, I, JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me, do hereby ordain :

**SECTION 1. COMPOSITION** - The City Awards Committee hereinafter referred to as (CAC) is hereby created with the following composition:

- Chairman:** Department of the Interior and Local Government (DILG) – Naga City  
**Co-Chairman:** Department of Justice (DOJ) thru City Prosecutor or authorized representative  
**Members:** Representative, City Peace and Order Council (CPOC)  
Representative, Naga City People's Council (NCPC)  
Representative, Naga City Police Office (NCPO)  
Representative, Philippine Mediation Center, Naga City

**SECTION 2. FUNCTIONS.** The CAC shall perform the following functions:

- a. Evaluate the 27 barangays of Naga City about the existing performance of Lupong Tagapamayapa;
- b. Set standards and guidelines for the selection of winners in line with Lupong Tagapamayapa Incentives Award;
- c. Select a nominee who will represent the city on provincial, regional and national level of Outstanding Lupong Tagapamayapa;
- d. Initiate programs and activities aligned with the existing laws and legal bases to

further improve the performances of Lupon Tagapamayapa of every barangay;

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
