RECONSTITUTING THE BIDS AND AWARDS COMMITTEE (BAC) OF THE CITY OF NAGA

WHEREAS, pursuant to Republic Act No. 9184, otherwise known as the Government Procurement Reform Act (GPRA), the members of the BAC of a local government unit shall have a fixed term of one (1) year, renewable at the discretion of the Head of Procuring Entity (HOPE);

WHEREAS, this special body must be reconstituted in view of personnel movement, election of new members and legal requirement to the Local Chief Executive (LCE) to restructure existing special bodies annually or when circumstances warrant;

WHEREAS, Engr. Leon B. Palmiano IV, City Engineer, designated as Vice Chairperson filed a leave of absence effective February 1, 2019;

WHEREAS, Engr. Gaudencio A. Asis, Jr., Assistant City Engineer, was designated as the Acting City Engineer;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the power vested in me by law, do hereby order the following:

Section 1. The Bids and Awards Committee (BAC), its Technical Working Group (TWG) and Secretariat are hereby reconstituted as follows:
