EXECUTIVE ORDER NO. 2019 - 007

ESTABLISHING THE CITY ASSESSMENT TEAM FOR THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB) IN THE CITY OF NAGA:-

WHEREAS, DILG Memorandum Circular No. 2018-194 dated 6 November 2018 launched the Seal of Good Local Governance for Barangay (SGLGB) to “Institutionalize a system of recognition and incentive awards for barangay governments and to provide mechanics for possible access to the Performance Challenge Fund (PCF) and other incentive mechanisms available”;

WHEREAS, in the SGLGB, qualified barangays are to be assessed in the core areas of (1) peace and order, (2) financial administration, and (3) disaster preparedness and in the essential areas of (1) social protection, (2) business-friendliness and competitiveness, and (3) environmental management;

WHEREAS, Assessment Teams in the national, regional, and city/municipality levels are to be constituted to administer the prescribed forms in documenting data and observations;

NOW THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers vested upon me by law do hereby order the following:

Section 1. FUNCTIONS. The Naga City SGLGB Assessment Team is hereby constituted to oversee and supervise the assessment of barangays by using the prescribed forms for SGLGB. Specifically, it aims to:

1. Intensify the advocacy and information campaigns in the community level;
2. Mobilize support and encourage sharing of data and information for each qualified barangay;
3. Improve the qualification to the SGLGB and capacity in general of the barangays in Naga City.

Section 2. COMPOSITION. The Naga City SGLGB Assessment Team shall be composed of the following:

1. DILG City Director, Chairperson
2. President of Liga ng mga Barangay – Naga City, Member
3. Representative from CMO, Member
4. Representative from NCPC, Member

Section 3. SCHEDULE OF ACTIVITIES. The SGLGB Assessment Team shall be guided by the following schedule:

Initial Assessment and Mentoring - February 2019

Assessment: Data Gathering - March 2019

Assessment: Data Validation and Certification - March 2019

Online Data Entry - April 2019

Section 4. TECHNICAL WORKING GROUP. To ensure the efficient performance and unhampered functionality of the Naga City SGLGB Assessment Team, the following offices/departments of the City Government of Naga are hereby into a Technical working Group to provide the manpower, logistical, and other support to the Team and to the barangays:

1. City Disaster Risk Reduction and Management Office
2. Liga ng mga Barangay
3. City Treasurer's Office
4. Public Safety Office
5. JMR Center for Good Governance
6. Naga City Police Office


Section 5. BUDGET. The resources for the operation of the Team and TWG shall be sourced out of the existing budget and appropriations of the herein enumerated support offices.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately
