**EXECUTIVE ORDER NO. 2019-019**

**CONSTITUTING THE COMMITTEE THAT WILL ASSIST THE PHILIPPINE NATIONAL RAILWAYS AND THE OFFICE OF THE UNDERSECRETARY FOR RAILWAYS OF THE DEPARTMENT OF TRANSPORTATION (DOTR) IN THE CONDUCT OF PRELIMINARY SURVEYS IN THE CITY OF NAGA FOR THE SOUTH LONG-HAUL PROJECT OF THE PHILIPPINE NATIONAL RAILWAYS :-**

**WHEREAS**, the City Government of Naga received a letter dated 23<sup>rd</sup> April 2019 addressed to the City Mayor from the Officer-in-Charge of the Philippine National Railways (PNR) and the Officer-in-Charge of the Office of the Undersecretary for Railways of the Department of Transportation requesting for assistance for the conduct of preliminary surveys relative to the South Long-Haul Project of the PNR in the City of Naga and further asking for a team to assist the survey team and for other requirements of the project;

**WHEREAS**, working with the project survey team on assistive capacity will give the city an opportunity to protect its interests that will benefit the city and its constituents;

**WHEREAS**, the whole project itself is a long overdue initiative dreamt about not only by the people of Naga but by all Bicolanos as well as it is seen to push forward economic progress in the region by providing a better mass transportation alternative for faster mobility of people and products;

**NOW THEREFORE**, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the power vested in me by law, do hereby order, the following:

**SECTION 1.** There is hereby constituted a committee for the purpose of assisting the Philippine National Railways and the Office of the Undersecretary for Railways of the Department of Transportation for the conduct of preliminary surveys for their South Long-Haul Project that will traverse the City of Naga, to wit:

1. Mr. Florencio T. Mongoso, Jr., Acting City Administrator
2. Mr. Reuel M. Oliver, Metro PESO Manager
3. Engr. Rolando SI Campillos, City Housing and Settlements and Development Officer
4. Engr. Gaudencio Asis, Jr., Acting City Engineer
5. Mr. Wilfredo B. Prilles, Jr., City Planning and Development Coordinator
6. Mr. Frank M. Mendoza, City Budget Officer

**SECTION 2.** The committee is hereby mandated to coordinate with the Philippine National Railways to establish the line of communication between itself and the


PNR/DOTr survey team, report to the City Mayor progress of the preliminary surveys and the final outcome upon completion thereof.
