CONSTITUTING THE CITY ANTI-DRUG ABUSE COUNCIL

WHEREAS, recognizing that the use of illegal drugs is a serious threat to public health, well-being and national security, the Department of the Interior and Local Government and the Dangerous Drugs Board issued Joint Memorandum Circular No. 2018-01 providing, among others, the constitution of Local Drug Anti-Abuse Councils and the implementing guidelines on their functionality and effectiveness;

WHEREAS, the City Anti-Drug Abuse Council, as acknowledged by the DILG and DDB in the aforesaid joint circular, has a critical role in the coordination and proper monitoring of drug-related incidents;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CONSTITUTION OF THE NAGA CITY ANTI-DRUG ABUSE COUNCIL. The Naga City Anti-Drug Abuse Council is hereby created to be composed of the following:


SECTION 2. CADAC SECRETARIAT. The Naga City Dangerous Drugs Board, headed by Mr. Jose B. Importante, shall serve as the Secretariat of the Naga City Anti-Drug Abuse Council.


SECTION 3. MEETINGS. The Council shall regularly meet every quarter. The day, time and venue of such regular meetings shall be agreed upon by majority of the members of the Council. A special meeting may be called upon by the Chairman whenever necessary.

To declare a quorum in any meeting of the Council, majority thereof must be present either in person or through their duly-authorized representatives.

SECTION 4. EFFECTIVITY. This Executive Order shall be effective immediately.
