**CONSTITUTING THE NAGA CITY CHILD-FRIENDLY LOCAL GOVERNANCE AUDIT INTER-AGENCY MONITORING TASK FORCE**

**WHEREAS**, DILG-DSWD-DEPED-DOH Joint Memorandum Circular No. 2019-01 provides for the creation of the Inter-Agency Monitoring Task Force to gather concerned local offices to deliberate, discuss and clarify issues/concerns in relation to the Revised Child-Friendly Local Governance Audit, as well as to advocate for the support and assistance for the promotion and realization of children’s rights based on the results of said audit;

**WHEREAS**, in building a self-reliant and caring community, it is imperative for the city government to fully support the progressive realization of children’s rights to survival, development, protection and participation;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. NAGA CITY CHILD-FRIENDLY LOCAL GOVERNANCE AUDIT INTER-AGENCY MONITORING TASK FORCE.** The Naga City Child-Friendly Local Governance Audit Inter-Agency Monitoring Task Force is hereby constituted to be composed of the following:

**SECTION 2. FUNCTIONS.** The Naga City Child-Friendly Local Governance Audit Inter-Agency Monitoring Task Force shall have the following duties and responsibilities:

1. Provide an orientation to the Local Council for the Protection of Children (LCPC) on the Child-Friendly Local Governance Audit Data Capture Form (CFLGA DCF) and corresponding data/documentary requirements;
2. Upon receipt of all data requirements, accomplish the aforementioned CFLGA DCF;
3. Present the initial results of the audit to the LCPC, which will serve as both a validation exercise and exit conference;

4. Upon clearance and approval with the LCPC, the CFLGA DCF shall be submitted to the Regional Inter-Agency Monitoring Task Force with all supporting documents thereof signed by the members thereof and duly-noted by the City Mayor.

**SECTION 3. EFFECTIVITY.** This Executive Order shall be effective immediately.
