CONSTITUTING THE NAGA CITY NATURAL FAMILY PLANNING COUNCIL

WHEREAS, the State also recognizes the right of spouses to found a family in accordance with their religious convictions and the demands of responsible parenthood;

WHEREAS, despite such right, the size of each family, however, must be dependent on the principle of responsible parenthood in order to promote the right of children to proper care, nutrition and support, as well as to protect them from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development;

WHEREAS, natural family planning is an efficient and effective tool for advancing both the State's interests to promote responsible parenthood and to safeguard the people's freedom of religion and belief;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. NAGA CITY NATURAL FAMILY PLANNING COUNCIL. The Naga City Natural Family Planning Council is hereby created.

The City Mayor or, in his absence, the City Vice Mayor, shall chair the Naga City Natural Family Planning Council.

The Family Ministry in Caceres shall serve as the council's Executive Director, while the City Population and Nutrition Office shall serve as its secretariat.

Members of the Council shall be composed of representatives from the following institutions:

- Department of Health
- Family Planning Organization of the Philippines
- Philippine Information Agency
- Naga City People's Council
- Naga City Police Office
- University of Nueva Caceres
- Ateneo de Naga University
- Naga College Foundation


- Committee on Education
