RECONSTITUTING THE NAGA CITY INVESTMENT BOARD

WHEREAS, Ordinance No. 97-114, otherwise known as *Naga City Investment Incentives Code of 1997*, created the Naga City Investment Board, defined its composition and enumerated its functions;

WHEREAS, calls for nomination to the Naga City Investment Board were sent to the private sector and to the Naga City People’s Council;

WHEREAS, after receiving the nominations from the private sector and the Naga City People’s Council and after undergoing the necessary process, the members of the board have been finally selected with a trust to boost the city’s development and to promote its priority investments in the fields of Information Technology-Business Process Management, Digital Start-up Ecosystem Development, High-Value Engineering (manufacturing for exports in an economic zone), and Real Estate/Commercial Complex Development (including the construction of tourism infrastructures);

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CHAIRPERSON AND VICE CHAIRPERSON OF THE NAGA CITY INVESTMENT BOARD. As provided by Ordinance No. 97-114, the City Mayor shall sit as chairperson of the Naga City Investment Board. The Vice Chairperson of the NCIB shall be elected by the members from the private sector, for subsequent confirmation of the City Mayor.


