**CONVENING THE NAGA CITY COUNCIL  
 ON DISABILITY AFFAIRS**

**WHEREAS**, persons with disability are vulnerable to socio-economic changes in society, thus requiring a comprehensive approach on provision of solutions to issues concerning PWDs;

**WHEREAS**, there is a need to set-up an integrated structure that will offer interdisciplinary recommendations for the development and welfare of PWDs;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. NAGA CITY COUNCIL ON DISABILITY AFFAIRS.** The Naga City Council on Disability Affairs is hereby constituted with the following composition:

**SECTION 2. FUNCTIONS.** The Naga City Council on Disability Affairs shall review and provide guidance to the direction and implementation of programs, projects and activities for persons with disability, as well as forward policy recommendations to the City Mayor.

**SECTION 3. COMMITTEES.** To aid in the expeditious performance of their tasks, the Naga City Council on Disability Affairs is hereby empowered to create committees, such as but not limited to the following:

- Committee on Advocacy
- Committee on Accessibility
- Committee on Livelihood, Training and Employment
- Committee on Education


**SECTION 4. COUNCIL SECRETARIAT.** The Persons with Disability Affairs Offices shall serve as Council Secretariat and provide administrative and technical support to its operations.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately.
