



ORDINANCE NO. 948

AN ORDINANCE AMENDING ORDINANCE NO. 181. S. 1957 BY INCORPORATING UNDER SECTION 1 THEREOF THE PROHIBITION OF PERSON OR PERSONS FROM LOITERING AND/OR ROAMING WITHIN THE COMPOUND OF PUBLIC SCHOOLS, BARANGAY HALLS, MULTI-PURPOSE CENTERS AND THE LIKE WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF NAGA: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Section 1 of Ordinance No. 181, S. 1957 is hereby amended as follows:

"Vagrancy: Any person who has no visible means of support and lives without lawful employment; or who keeps a house of public gambling or gaming; or of prostitution; or act as pimp or procure; or who is a common gambler or prostitute; or who, for the most part, maintains himself by gambling or begging; or who habitually idly loiters about, or wanders abroad, visiting or staving about hotels, cafes, drinking salons, houses of ill reputes, gambling houses, railroad depots, wharves, public waiting rooms, or parks, or who lodges in courthouses, lumber yards or in the open air not giving a good account of himself; or who habitually accompanies prostitutes or other persons of notoriously bad repute; or who wanders abroad and begs or places himself in the street or other public places to beg by look, word, or sign, or to receive alms, or who being diseased, maimed, or deformed so as to be an unsightly or disgusting object, exhibits himself in a public street or place; or who is found in or about any dwelling houses, warehouse, coach house, stable or outhouse, or in any enclosed yard, garden or area for any unlawful purpose/s; or who loiters and/or roam within the compound of any public schools, barangay halls, multi-purpose centers and the like within the territorial jurisdiction of the City of Naga, without any lawful purpose at any time of day or night, shall be deemed a vagrant."

SECTION 2. - The penalty prescribed therein as provided for in Section 2 thereof is hereby amended as follows:

"Penalty: Any person or persons deemed vagrant, upon conviction, thereof, shall be punished by a fine of not less than One Hundred (P100.00) Pesos or not more than Five Hundred (P500.000) Pesos or imprisonment of not less than fifteen (15) days but not more than thirty (30) days, or both such fine and imprisonment at the discretion of the court."

SECTION 3. - This ordinance shall take effect thirty (30) days after its approval.
