ORDINANCE NO. 1986-004

**AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 543, S. 1976
DECLARING CERTAIN SPACES AT THEN NAGA CITY PUBLIC MARKET FOR LEASE AND
PRESCRIBING RENTALS FOR THE USE AND OCCUPANCY THEREOF: -**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Article C, Section 5c.02 (a) of Ordinance No. 543, S 1976 is hereby amended to include as No. 7 thereof a General Merchandise (chucheria) section which shall include all kinds of goods, merchandise and accessories such as fancy earrings, rings, necklace, bracelets, hairclips, headbands, beauty products, combs, facial powder, lotions, cosmetics, deodorants, soaps, scissors, key chains, toys, razors, lighter fluids/gas, flints, nail polish, belts, wallets, newspapers, magazines, comic books, school and office supplies, pins, needles, thread mothballs, eye glasses, hats, rubber stamps, lighter repair and other allied items of similar kind.

SECTION 2. - Article C, Section 5c.03 (a) of Ordinance no. 543, S 1976 is likewise amended to include as No. 6 thereof specified adjacent spaces extending seven (7) inches from the four sides of the posts within the market premises along the following:

Location	Post No.	Rate per month
a) General Luna St.	1 – 26	P 60.00
b) Igualdad St.	27 – 54	45.00
c) Zamora St.	55 – 65	45.00
d) Prieto St.	66 – 70	60.00
e) Padian St.	71 – 79	45.00
f) Short street to Riverside	80 – 87	45.00

And further, as No. 7 thereof, certain open spaces at the open patio No. 2 as per hereto attached Annex “A” and made an integral part hereof with an area of 10 square meters at 2m x 5m per stall/space at the rate of 0.48 centavos/sq.m./day or P144.00/month and the open space situated along Padian Ext. St. before ascending Ramp #1 of the Naga City Public Market with an area of 9.75 sq.m. at the rate of P 162.00 per month which open spaces shall be an extension of the dry goods and grocery section.

SECTION 3. - The rates of rentals per month of spaces/stalls as herein provided shall not include the fees for Mayor’s Permit, business tax, sanitary permit, garbage and fire inspection which fees are subject of existing laws, ordinances, rules and regulations.

SECTION 4. - The manner of disposition and awards of the aforementioned stalls/spaces as herein provided shall be vested and undertaken exclusively by the Market

Awards Committee or its duly authorized representative in accordance with the existing laws, rules and regulations.

SECTION 5. - The construction of uniformed stalls/spaces and display shelves/stands at open patio No. 2 and the posts respectively shall be undertaken by and for the account of the stall/space awardee subject to existing laws, conditions, specification, rules and regulations which may now or hereinafter be promulgated by the duly constituted authorities of the city.

SECTION 6. - The subleasing of the stalls/spaces as herein provided and the sale on wholesale and retail of goods and merchandise not otherwise provided or for any violation of the pertinent provisions of this ordinance or of the rules and regulations which may now or hereinafter be provided shall be punished with a fine of not more than P1,000.00 or imprisonment of not exceeding six (6) months or both such fine and imprisonment at the discretion of the court.

SECTION 7. - If for any reason any section or provisions of this ordinance shall be held to be unconstitutional or invalid by as court of competent jurisdiction, such judgment shall not affect or impair the other provisions, sections or parts thereof which shall continue to be in force and effect.

SECTION 8. - All ordinances, rules and regulations or parts thereof, which are in conflict with or inconsistent to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 9. - This ordinance shall take effect immediately upon its approval.
