ORDINANCE NO. 88-021

AN ORDINANCE AMENDING SECTIONS IN ARTICLES B, C & F OF CHAPTER IV OF ORDINANCE NO. 543, OTHERWISE KNOWN AS "THE REVENUE CODE OF THE CITY OF NAGA" BY ADDING CERTAIN PROVISIONS AND INCREASING CERTAIN LOCAL REGISTRY FEES: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Certain Sections of Articles B, C & F of Chapter IV of Ordinance No. 543, otherwise known as "The Revenue Code of the City of Naga" are hereby amended to read as follows:

ARTICLE B. - LOCAL REGISTRY FEES AND PERMIT FEES FOR CADAVER DISPOSITION

SECTION 4B.01. - IMPOSITION OF FEES. - There shall be collected the following fees for services rendered by the civil registry of Naga City:

a. For the registration of documents and for certified copies of documents on file in Local Civil Registrar:

11. Late Registration of births, marriages and deaths:
(Subject to the provisions of Sections 2 & 5 of PD No. 651, as amended by PD No. 766 dated August 8, 1975.)

Beyond 30 days but not exceeding one (1) year P 30.00

12. Late Registration of births, marriages and deaths beyond one (1) year 50.00

13. Certified true Copy of certified Xerox copy of:
a. birth Certificate 10.00
b. marriage certificate 15.00

14. Certified true copy or certified Xerox copy of death certificate 10.00

ARTICLE C. – MARRIAGE LICENSE AND SOLEMNIZATION FEES

SECTION 4C.01. - IMPOSITION OF FEES. - There is hereby levied the following fees for contracting marriage:

1. Application Fee P 30.00
