ORDINANCE NO. 88-042

AN ORDINANCE AMENDING CERTAIN SECTIONS OF ORDINANCE NO. 965, S. 1984 AUTHORIZING THE USE AND OCCUPANCY OF CERTAIN OPEN SPACES AT THE NAGA CITY PUBLIC MARKET PRESCRIBING RENTALS THEREON DURING THE DURATION OF THE CITY CHARTER ANNIVERSARY AND THE HOLIDAY SEASONS FROM DECEMBER 6, 1984 TO JANUARY 6, 1985 AND EVERY YEAR THEREAFTER: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Sub-section A of Section 1, Section 2 of Section 3 of Ordinance No. 965, 984 are hereby amended to read as follows:

“SECTION 1:

- A. The open spaces between posts of the Naga City Public Market along General Luna St., and Jaime Hernandez Ave., (formerly Igualdad St.,) Naga City, as appearing on the revised floor plan of the Naga City Public Market which is hereto attached as Annex “A-1”, incorporated herein and made an integral part of this ordinance by way of reference, at rates herein below classified which shall include rental, mayor’s Permit, Business Tax, Sanitary Permit, Garbage Fee and Fire Inspection Fee for one (1) month per space;
- aa. Spaces # 1-46, along General Luna St.
Size: 1m x 2m 250.00/space
- bb. Spaces #47-74 situated at every post along Jaime Hernandez Ave., (formerly Igualdad St.)
Size: 1m x 1m including the diameter of the post 250.00/space

“SECTION 2. - Designated spaces #1-46, inclusive, along General Luna St., and space #47-74 situated at every post along Jaime Hernandez Ave., (formerly Igualdad St.,) inclusive, as per Annex “a-1” shall be devoted exclusively to the display, retail and sale of Christmas goods, items, merchandise and/or wares such as, cards, gifts, decors, ornaments, toys, fruits, synthetic Christmas trees, lights, lantern and the like and sale retail and wholesale of goods, items, merchandise not otherwise provided such as handicrafts, glasswares, footwears, rice, sarisari, fastfoods and the like is strictly prohibited;

“SECTION 3. - The manner of disposition and award of the aforementioned spaces as herein provided shall be vested and undertaken exclusively by the Market committee or its duly authorized representative and same shall be open to all qualified

persons by way of drawing of lots in accordance with the rules and regulations promulgated by the Market Awards committee.

SECTION 2. - All ordinances, rules and regulations or parts thereof which are in conflict with or inconsistent to the provisions of this ordinance are hereby repealed, amended, modified or suspended temporarily for the duration as aforestated;

SECTION 3. - This ordinance shall take effect immediately upon this approval.
