**ORDINANCE NO. 89-094**

**AN ORDINANCE SPECIFYING SPACE CAPACITY MEASURE OF ALL JEEPNEY AND BUS TERMINALS AND REQUIRING TERMINAL OPERATORS TO ISSUE TERMINAL IDENTIFICATION STICKERS TO ALL THEIR VEHICLES AND TO SUBMIT TO THE CITY MAYOR'S OFFICE AN UPDATED LIST OF JEEPNEY AND/OR BUS OWNERS/OPERATORS WITH THEIR CORRESPONDING NUMBER OF VEHICLES UTILIZING THEIR TERMINAL: -**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**ARTICLE I. – SPACE CAPACITY MEASURE OF TERMINALS**

**SECTION 1.** - The space Capacity Measure is defined as the maximum standard area of space to be allotted per vehicle in order to determine the maximum number of vehicles to be allowed a land transport terminal at one time.

**SECTION 2.** - The following space capacity measures of vehicles to utilize land transport terminals in Naga City will be required:

1. For Jeepney Terminals – The space capacity measures is 18 square meters per vehicles.
2. For bus/Mini-bus Terminals – The space capacity measure is 65 square meters per vehicle.

**ARTICLE II. – TERMINALS IDENTIFICATION STICKERS**

**SECTION 1.** - Every terminal operator is required to provide identification stickers to all vehicles utilizing his/her terminal.

**SECTION 2.** - For existing terminal operators, a sample of their identification stickers will have to be submitted to the City Mayor's Office, and to require all their vehicles to post these stickers a month after the validity of this ordinance.

**SECTION 3.** - For future terminal operator applicants, a sample of I.D. stickers will have to be attached to the business/Mayor's Permit application as a requirement for processing. All vehicles in these future terminals will be required to have a sticker on the first day of operation.

**SECTION 4.** - All public utility jeepneys/mini-buses/buses are required to post terminal identification stickers on the right side, lower portion of their vehicle windshield.

**ARTICLE III. – SUBMISSION OF UPDATED LIST OF VEHICLES BY TERMINAL OPERATORS**

**SECTION 1.** - All land transport terminal operators are required to submit to the City Mayor's Office a list of vehicle owners/operators with their corresponding number of vehicles which will be utilizing their terminals on the day they secure a Business/Mayor's Permit for their terminal. Thenceforth, an updated list of vehicle owner/operator with their corresponding number of vehicles shall be submitted by all terminal operators to the mayor's Office every last day of the 1<sup>st</sup> month every quarter.

**ARTICLE IV. – PENALTY CLAUSE**

**SECTION 1.** - Any public utility vehicle owner/operator/driver found to violate any of the pertinent provisions of this Ordinance shall be subjected to a fine of P 500.00 per apprehension.

**SECTION 2.** - Any terminal operator who violates any of the pertinent provisions of this ordinance shall be subjected to a fine of not exceeding P 1,000.00 or revocation of his/her Business License and Mayor's Permit, or both at the discretion of the court.

**SECTION 3.** - This ordinance shall take effect upon its approval.
