ORDINANCE NO. 90-004

AN ORDINANCE ESTABLISHING THE "TIMBANGAN NG BAYAN" PROJECT AND APPROPRIATING FUNDS FOR THE PURPOSE: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. – A. "Timbangan ng Bayan" project is hereby established in the City of Naga;

SECTION 2. – DEFINITION OF TERMS. – For the purpose of this ordinance, "Timbangan ng Bayan" shall be a project of the city government of Naga where it puts up permanent weighing scale in specific sections of the Naga City Public Market where customers can weigh and ascertain the correct weighs of the goods they buy in the market, specifically meat, fish, rice, vegetables, sugar, and the like;

SECTION 3. – GUIDELINES. – The following guidelines are hereby formulated in order to implement the project:

- a) The city government of Naga thru the Market Superintendent shall put weighing scales in specific sections of the Naga City Public Market where goods are sold by way of their respective weights, in grams or in kilos;
- b) For the purpose of safeguarding the weighing scales, individual safety closet shall be constructed in the specified sections of the market and the same shall be opened during business hours under the general supervision of the Market Superintendent;
- c) For the initial implementation of the project one (1) weighing scale shall be installed at the meat-chicken section; and one (1) at the rice section;
- d) The representatives of the Market Superintendent who shall tend and manage each weighing scale shall make record of every goods found to be under weight, its actual weight, the name of the customer, the name of the establishment where the goods were bought, and the name of the owner or operator of the establishment, for the purpose of filing appropriate case, in accordance with the existing law, ordinances, rules and regulations,

SECTION 4. – FUNDING. – The amount of Seven Thousand Five Hundred (P 7,500.00) Pesos from the Surplus in the General Fund is hereby appropriated for the purchase of three (3) weighing scales and construction of the safety closets, for the purpose of implementing this project.

SECTION 5. – REPEALING CLAUSE. – All ordinances, rules and regulations inconsistent with this ordinance are hereby repealed, amended and /or modified accordingly.

SECTION 6. – This ordinance shall take effect upon its approval.
